1 . 2018 Active Transportation Annual Report

Report dated December 27, 2018 from the General Manager of Growth and Infrastructure regarding 2018 Active Transportation Annual Report.

Marisa Talarico, Active Transportation Coordinator, provided an electronic presentation regarding the 2018 Active Transportation Annual Report.

The following resolution was presented:

OP2019-02 McIntosh/Kirwan: THAT the City of Greater Sudbury designates the first lane from the east curb and the first lane from the west curb of Copper Street, from Kelly Lake Road to Martindale Road, as a cycling facility (Bike Lane);

THAT the City of Greater Sudbury designates the first lane from the east curb and the first lane from the west curb of Martindale Road, from Regent Street to Ontario Street, as a cycling facility (Bike Lane);

THAT the City of Greater Sudbury designates the first lane from the east curb and the first lane from the west curb of Kelly Lake Road, from Copper Street to Southview Drive, as a cycling facility (Bike Lane);

THAT the City of Greater Sudbury designates the first lane from the south curb and the first lane from the north curb of Worthington Crescent, from Riverside Drive to Ramsey Road, as a cycling facility (Bike Lane);

THAT the City of Greater Sudbury prepares a by-law to amend Traffic and Parking By-Law 2010-1 to implement the recommended changes, as outlined in the report entitled "2018 Active Transportation Annual Report", from the General Manager of Growth and Infrastructure, presented at the Operations Committee meeting on January 21, 2019.

Question Period and Announcements

Snow Removal on Notre Dame Between Leslie Street and Louis Street

Councillor Landry-Altman asked what needs to occur in order for snow removal to take place in the area of Notre Dame between Leslie Street and Louis Street.

Tony Cecutti, General Manager of Growth and Infrastructure, stated that it is a challenging area as there is a narrow boulevard, little asphalt and a steep slope heading down to the housing complex. They would prefer to have a section of asphalt between the curb in the sidewalk. It would be difficult

as there would be a need for a retaining wall in order to accommodate the pedestrian access and have temporary storage. If they were to use the existing asphalt boulevard for pedestrian activity they would have to pick the snow up and remove it every time it snowed. They are looking at an option in the detailed design for the pedestrian corridor and will consider phases in order to implement possible solutions sooner.

Councillor Landry-Altmann asked if blading is an option in this area.

Tony Cecutti, General Manager of Growth and Infrastructure, stated that it would be difficult to implement blading due to the constraints in the area. They are looking at the design and if there is something they can implement ahead of time to accommodate the pedestrians, it will be part of the process.

Councillor McIntosh asked how much it would cost to remove the snow.

Tony Cecutti, General Manager of Growth and Infrastructure, stated that he would be able to provide the cost of snow removal at a subsequent meeting.
