# **Question Period and Announcements**

#### **Road Conditions**

Councillor Landry-Altmann asked if the bad condition of the roads is due to the weather.

Tony Cecutti, General Manager of Growth and Infrastructure Services, stated that there have been challenging weather events. He further stated that no changes have been made to the winter road maintenance policies. The same approaches as used in the past are continuing and will be until they are directed otherwise.

#### Salt vs Sand

Councillor Landry-Altmann asked the difference between salt and sand routes and when each are used.

Tony Cecutti, General Manager of Growth and Infrastructure Services, stated that a class one (1) to three (3) roadway is treated as a salt route and a class four (4) to six (6) roadway is treated with sand. There are a few roads with significant geometric challenges, such as a road being very steep,

which will sometimes be salted despite being a class four (4) roadway. The classifications are based on the speed limit and volume of traffic. A roadway with a high speed limit or a high volume of traffic will be classed in the one (1) to three (3).

### **Public Information on Winter Control**

Councillor Kirwan asked if the Communications Department could release the equipment type and when it is sent out during varying events of winter control to the public.

Tony Cecutti, General Manager of Growth and Infrastructure Services, stated that he would be happy to update the City's Website in order to provide more information. However, he would like to caution the Committee that the number of vehicles they have is dependent on the status of the fleet. There are occasions when a piece of equipment is not available due to required repairs or changes of personnel during the day.
