# **Question Period and Announcements**

#### Thorncliffe and Forestdale Traffic Signage

Councillor Landry-Altmann asked if there could be traffic signage put in place for the cars coming over the hill on Montrose to help traffic near Thorncliffe and Forestdale.

Joe Rocca, Traffic and Asset Management Supervisor, stated that they will take a look to see what improvements can be made in the area.

#### **Digital Speeding Solar Panels**

Councillor Cormier asked if they could implement more digital speed panels throughout the community.

Tony Cecutti, General Manager of Growth and Infrastructure Services, stated that this signage seems to be more in demand recently. They will revisit the demands they have on file and look into the availability of the equipment. They agree with Councillor Cormier's inquiry and will get back to him with information.

Councillor Landry-Altmann asked if the statistics of the solar panels on Barrydowne have been reviewed.

Joe Rocca, Traffic and Asset Management Supervisor, stated that they are in the final stages of compiling the information and will be providing it shortly.

#### **Traffic Signs on Power Street and Niemi Road**

Councillor Vagnini asked if extra 50km/h speed signs could be posted in the Power Street and Niemi Road area as there is high concern of people speeding.

Joe Rocca, Traffic and Asset Management Supervisor, stated that typically speed limit signage is posted at the beginning of a street where there is a change of a higher speed to a lower. They can review Power Street and Niemi Road to make sure that the signs are in place and to see if there is opportunity to add extra signage.

# **New Direction on Lagace**

Councillor Landry-Atlmann asked if new signage will be installed to warn drivers of the change in direction on Lagace.

Joe Rocca, Traffic and Asset Management Supervisor, stated that signs will be installed and a media release will be issued once the change takes place.

#### Recess

At 4:46 p.m. the Committee recessed.

#### Reconvene

At 4:48 p.m. the Committee reconvened.

#### Seismic Testing on Radar Road

Councillor Kirwan asked what are the implications of the tests they are conducting in this area and is there cause for concern of possible sink holes. And if so, who will be doing the work to repair.

Tony Cecutti, General Manager of Growth and Infrastructure Services, stated that this is a project that is being conducted by Laurentian University through one of the research professors. They have installed a number of monitoring devices throughout our roadways. They are using a device to create a short period of vibration in the road simulating a seismic event and the information is recorded. The University did ask for permission to do testing on our roadways and they will be done in about a week. They go to an area once to implement these vibrations mostly in rural areas. Any damage caused by the event would be the responsibility of the University.

Councillor Kirwan asked if there is the possibility for any long term effect.

Tony Cecutti, General Manager of Growth and Infrastructure Services, stated that they do not anticipate any long term implications of this testing.

#### **Clearing Out Drainage Ditches**

Councillor Kirwan asked why the drainage ditches in the outlining area are left with sand once they have been cleared out and why it gets done in the fall.

Randy Halverson, Director of Linear Infrastructure Services, stated that the ditching program usually starts in August and runs to the end of the summer season. The ditches build up with different materials and they need to clean them and bring them to a normal grade so they drain properly. They don't normally want to remove grass, but when a large area is being cleared they do. There is likely an upstream drainage problem.

# **Illegal Dumping**

Councillor Kirwan asked what is the process if someone would like to report illegal dumping of garbage in an area. Does the City clean up on private property or is a letter sent to the property owner.

Tony Cecutti, General Manager of Growth and Infrastructure Services, stated that if the dumping is along a public roadway City staff would go and investigate and clean up the garbage. If the garbage is on private property, city staff would not clean it up. It is the responsibility of the property owner to clean up any waste that is disposed of, which can be enforced by the property standards requirements. These situations are dealt with as they come up on a case by case basis.
