QUESTION PERIOD AND ANNOUNCEMENTS

Sand and Salt Disposal

Councillor Landry-Altman asked what methods the City has for disposal of road sand and salt.

The General Manager of Infrastructure Services replied a report would be brought to the Committee to explain the process as there are various disposal methods.

Recycling Sand and Salt

Councillor Landry-Altman asked if the road sand and salt is, or could be, used as fill in the landfill or recycled in any way and asked if there was any value to recycling the materials.

The General Manager of Infrastructure Services replied that any material that can be used at the landfill site has tremendous value, as the City uses 60,000 cubic metres of cover material each year. However, because the material needs to be removed every day only a certain quality of material can be used. Material from the roadway often has a mixture of different materials and is not always conducive for use at the landfill.

Landfill Visit

Councillor Landry-Altman asked if a site tour could be set up for Councillors interested in visiting the landfill.

The General Manager of Infrastructure Services replied that any Councillors interested in a site visit could send an email and arrangements would be made for a tour of the landfill.

QUESTION PERIOD AND ANNOUNCEMENTS (cont'd)

Spring Cleanup

Councillor Kirwan asked if it would be possible to extend or delay the spring residential tipping fee holiday as residents have not had the opportunity to clean their yards because of lingering snow. He suggested a system where a number of free passes be provided to each household for use throughout the year instead of a set timeframe for a tipping fee holiday, which would alleviate the two weeks of intense use of landfill sites.

The General Manager of Infrastructure Services replied he would get back to the Councillor through email in regard to an extended or different time period for the tipping fee holiday. He noted there may be financial implications that he would have to look into. He suggested free passes could be considered as a secondary issue.
