Winter Control Budget	Councillor Lapierre asked what happens to the surplus if the entire snow removal budget is not used during a particular year.
	The General Manager of Infrastructure Services replied that the budget is based on average costs for a season. He noted any under expenditures go into the reserve for winter control and that when snow removal exceeds budget allocations money is taken from the reserve. He added that while there was little snowfall during the beginning of this season snowfall during January through March was much higher than average.
