QUESTION PERIOD AND ANNOUNCEMENTS

Snow Removal Access streets

Councillor Kirwan asked if there is a policy for access streets to be cleared and if there is a way for those intersections to be cleared sooner to provide access to major roads.

The General Manager of Infrastructure Services replied the snow plows follow a route designed by staff and do not normally fall out of their route. He explained deviation from the route incurs additional costs. He noted a call out mobilizes the entire fleet but that plows are out clearing snow prior to that time as well.

Equipment Usage

Councillor Cormier asked how many pieces of equipment are out on the road during a full call out.

The General Manager of Infrastructure Services replied the number varies but usually 40-50 pieces of equipment are on the road during that time.

Public Availability of GPS

Councillor Cormier asked if the City is closer to making GPS publically available.

The General Manager of Infrastructure Services noted they hope to have the GPS system available to the general public by next winter.

Salt Alternatives

Councillor Cormier asked if any alternatives to salt have been explored.

The General Manager of Infrastructure Services responded staff keeps abreast of industry changes but there is not currently one single cost effective alternative to salt.

The Director of Roads & Transportation Services noted a number of routes got converted from salt routes to sand routes in 2006 and the City employs different methods to reduce the use of salt. He explained different products are used for example on the airport runways but that those products are not cost efficient and that staff continues to monitor product trials in other communities.
