# **Presentations**

1. Report dated May 18, 2012 was received from the Chief of Emergency Services regarding Ontario Fire Marshal (OFM) Review of Fire Protection (Prevention) Services in the City of Greater Sudbury — Findings and Recommendations.

OFM Review of Fire Protection Services in the City of Greater Sudbury Report dated May 23, 2012 was distributed to Committee members under separate cover.

Art Booth, Operations Manager, Office of the Fire Marshall, and Diane McCullough, Fire Protection Specialist, Office of the Fire Marshall, made a verbal presentation regarding the Review of Fire Protection Services in the City of Greater Sudbury. Art Booth introduced the members of the review team and Diane McCullough outlined in detail the twenty-five recommendations.

The following recommendation was presented:

CS2012-24 Cimino/Belli: THAT the City of Greater Sudbury accept the Review of Fire

Protection (Prevention) Services in the City of Greater Sudbury from the Ontario Fire Marshal (OFM);

AND THAT the Chief of Emergency Services be asked to return a formal response to those recommendations within 90 days and report back to the Community Services Committee at their meeting of September 24, 2012.

# **Managers' Reports**

Report dated May 11, 2012 was received from the General Manager of Community Development regarding Municipally Owned Trailer Parks – 2012 Payment Plan Fees.

The following recommendation was presented:

CS2012-25 Belli/Cimino: WHEREAS the City of Greater Sudbury operates three (3) seasonal trailer parks;

AND WHEREAS there has been public interest in extending the camping season by 18 days (opening daily on Victoria Day weekend and closing the third Sunday in September);

AND WHEREAS Council approved an increase in user fees in 2012 in order to align the rates with Provincial Park rates;

AND WHEREAS the increase in rates will cover the additional cost for the additional 18 camping days;

AND WHEREAS campers have requested that the City implement a payment plan due to the significant rate increases in 2012;

THEREFORE BE IT RESOLVED THAT the City of Greater Sudbury approve the original user fee published in the 2012 Spring and Summer Leisure Guide to be paid immediately and the balance of the fee, (2012 increase rate) be paid by July 15, 2012. The payment plan would apply for the 2012 camping season on a one-time basis only.
