

Background

Fire protection in Ontario is a provincially mandated municipal responsibility. It is the responsibility of municipal councils to be familiar with general fire protection requirements, practices and procedures (ie. *The Fire Protection and Prevention Act, 1997*). Whereas in the *Municipal Act 2001,* where a municipality establishes and maintains a fire department, it is required that an *"Establishing and Regulating By-law"* be created. As such, the City created and adopted By-law 2010-16.

Since the last by-law amendment, there has been significant change in the corporate reporting structure and the management

of Fire Services as well as trends and issues that require the existing by-law to be renewed. In addition, the current by-law does not provide an accurate depiction of the core services being provided by Fire Services and therefore creates potential liability for the Corporation.

A highlight of changes under consideration includes but is not limited to the following:

- 1. The creation of the Emergency Services Department, incorporating the following Divisions: Emergency Medical Services, Emergency Management, and Fire Services, is to be reflected in the revised by-law,
- 2. The current services being provided, complimented by their relevant definitions will be provided as an appendix to the by-law and will become the services "approved" by Council through the adoption of a revised by-law,
- 3. An overview of the approved services being provided by specific fire stations will be incorporated,
- 4. To reflect the diversity of the geographic and topographical nature of the City of Greater Sudbury and the staffing make-up of the Fire Services Division, the definition of "limited services" will be added and the Levels of Service section will be incorporated into the by-law to reflect the provision of emergency response realities and thereby reduce potential liability for the Corporation,
- 5. Changes in text, definition(s), and general wording to reflect changes to current fire services affecting legislation such as amendments to the *Fire Protection and Prevention Act*, and

"Objectives" in conjunction with current Corporate and master fire service plans, and a comprehensive listing of "Core Services" will also be included in this revised by-law.

The draft by-law will be consistent with the recommendations of the Office of the Ontario Fire Marshal and will be comparable to other municipal fire department establishing and regulating by-laws. A draft of our revised by-law is now under review by the City's Legal Services. Upon completion of Legal Services' review, Emergency Services will return to the Community Services Committee with the by-law for the Committee and Council's consideration.

Overview

At the August 10th 2011 Council meeting, Council requested staff to establish a Parks By-law for the City of Greater Sudbury. This information report has been prepared to identify some of the areas for consultation with the public. Attached are copies of the City of Sudbury Parks By-law and a list of properties.

Background

The Leisure Services 2011-2015 Strategic Plan identifies a planned action for a Parks By-law for the City of Greater Sudbury.

The by-laws of other municipalities have been reviewed as part

of this process: Toronto, Oshawa, Sault Ste. Marie, Ottawa, Niagara Falls, Windsor, Hamilton, North Bay, Mississauga, Barrie, Woodstock, London, Orillia, Kitchener, Timmins, Brampton and Town of Huntsville.

Definition of a Park:

"Park" is defined as land and land covered by water and all portions of it owned by or made available by lease, agreement or otherwise to the City, that is or may be established, dedicated, set apart or made available for use as public park, parkland, trails, welcome centres, ski hills, open space or any lands that are zoned P within the City of Greater Sudbury Zoning By-law, including any and all property, buildings, structures, facilities, erections, improvements located in or on the land, save and except where the land is governed by other by-laws of the City.

The City has been contacted by citizens and users in regards to parks related concerns and issues and these areas, not currently and/or partly governed by policy, will be discussed with the public for consultation prior to the draft by-law being presented for consideration to the Standing Committee.

1. Motorized Vehicles in Parks

Several concerns have been raised in regards to motorized vehicles using community trails located throughout the City.

2. Dog Leash Free Zones

An off leash dog park committee (D.O.G.S.) was established in 2010. The committee has received financial support from the City along with a contribution from Ward 11 Healthy Community Initiative fund and have implemented a fund raising campaign to realize the first dog park in the City of Greater Sudbury. The site is located on City owned property located at the corner of Donna Drive and Second Avenue North and is expected to be officially opened in 2012. The Parks By-law should deal with consideration of pets within city parks.

3. Smoking

In the last few years, concerns have been received from users of play fields related to smoking on park property. The City's current Smoking By-law (2004-232) Part 1 - Smoking in Public Places identifies "entranceway" as the area within a nine metre radius surrounding any entrance to a public building or workplace but does not include a public highway. The concerns received from citizens have been specific to smoking near public seating (bleachers), splash parks, play equipment etc.

In the City of North Bay, no person shall smoke on the grounds of the outdoor sports complex including all fields, buildings, parking lots and all other passive recreational areas within park boundaries.

In the City of Toronto, while in a park, no person shall smoke tobacco or hold lighted tobacco:

(A) - within a nine metre radius surrounding the edge of any playground safety surface or any playground equipment,

(B) - within a nine metre radius surrounding the edge of any wading pool, basin or splash pad safety surface, or

(C) - within any zoo or fenced area

4. Public Boat Launching Facilities

A number of city parks provide boat launching facilities. Public boat launches will be identified in the draft Parks By-law.

The City provides a public boat launching site in Bell Park off Ramsey Lake Road. In 1999-2000, the City constructed a building on site which provided public washrooms along with equipment to wash boats being launched at this site. The purpose of this service was to ensure that all boats were cleaned prior to launching in order to control zebra mussel entering the lake and to remove dirt such as oil, gas,etc. The service was originally to be provided through a private partnership agreement. The agreement was not realized resulting in the service not being offered. Other concerns raised by the public include winter access to Bell Park by vehicles onto Ramsey Lake from the boat launch.

5. Midways/Carnivals

The zoning by-law permits carnivals on properties zoned C5-Shopping Centre for commercial only. The City receives requests to operate midways on park properties annually.

6. Commercial Activities

Special Events organizers are authorized under permit to allow food vendors, selling of merchandise, souvenirs, art etc. The City has leased existing concessions located at a number of parks. The department has been requested from vendors to set up portable concessions, selling of merchandise, souvenirs etc. at major community parks such as Bell Park/Boardwalk during the summer months.

7. Parks Security/Closing hours

The City operates a parks security program. The program includes a stationary security program at Bell park from 6 p.m. to 2 a.m. seven days a week and two mobile units on a schedule from 7 p.m. to 3 a.m. seven days a week, patrolling sites throughout the City pre-selected by parks services. The parks security have delt with a number of issues including vandalism, drinking in parks, gatherings in parks past closing

hours, etc. The draft parks by-law/public consultation will include a review of closing hours.

Community Consultation

Three (3) open houses which will be scheduled in May will provide the public/stakeholders/park users with the opportunity to review the draft by-law and provide input and suggestions. The results of the community consultation and the draft parks by-law will be presented to Council for consideration in October, 2012.

Article 1 INTERPRETATION

594.1.1 Chattels - defined

Without in any way limiting the generality of the word, "chattels", includes pedal boats, canoes, row boats, beach chairs, beach lounges and towels.

594.1.2 Superintendent - defined

"superintendent" means the Director of Parks and Recreation.

594.1.3 Vehicle - defined

"vehicle" includes a motor vehicle, bicycle, trailer, traction engine, farm tractor, road building machine and any vehicle drawn, propelled or driven by any kind of power, including muscular power.

Article 2

GENERAL PROVISIONS

594.2.1 Alcoholic beverages - prohibited - exception - licensed No person shall have, bring into, or keep in any park or recreational area of the City of Sudbury for whatever purpose, any spirituous, fermented or intoxicating liquors of whatsoever nature and kind unless such person has received a license so to do from the Ontario Liquor License Board.

594.2.2 Sale - goods - merchandise - permission - required No person shall sell, offer for sale or keep for sale in any park or recreational area of the City of Sudbury, goods, wares, merchandise, or refreshments of whatsoever nature and kind without first having received written permission to do so from the Council.

594.2.3 Rental - chattels - other - permission - required

No person shall rent, offer to rent or keep for renting, any chattels of whatsoever nature and kind in any park or recreational area of the City of Sudbury without the prior written permission of the Council.

594.2.4 Damage - person - personal property - prohibited No person shall cause injury to any other person or his/her personal property in any park or recreational area of the City of Sudbury.

594.2.5 Damage - park property - prohibited

No person shall damage any park property of whatsoever nature and kind in any park or recreational area of the City of Sudbury.

594.2.6 Destruction - trees - shrubs - fixtures - prohibited

Without in any way limiting the generality of Section 594.2.5, no person shall injure, hurt, deface, tear or destroy any ornamental or shade tree, shrub, plant, flower, flower bed or any statue, fountain, vase or fixture, ornament or utility in any park or recreational area of the City of Sudbury.

594.2.7 Promotions - distribution - permission - required

No person shall in any park or recreational area of the City of Sudbury distribute, offer to distribute or bring into such park or recreational area for the purpose of distribution, any kind of promotional material of whatsoever nature and kind without the prior written permission of the Director of Parks and Recreation.

594.2.8 Promotions - exposure - written permission - required

No person shall in any park or recreational area of the City of Sudbury expose, offer to expose or bring into such park or recreational area for the purpose of exposing, any kind of promotional material of whatsoever nature and kind without the prior written permission of the Director of Parks and Recreation.

594.2.9 Promotions - posting - permission - required

No person shall in any park or recreational area of the City of Sudbury post, offer to post or bring into such park or recreational area for the purpose of posting, any kind of promotional material of whatsoever nature and kind without the prior written permission of the Director of Parks and Recreation.

594.2.10 Promotions - posting - on tree - structure - prohibited No person shall in any park or recreational area of the City of Sudbury stencil or affix any notice or bill or promotional material of whatsoever nature and kind to any property in such park or recreational area including any tree, shrub, bush, plant, flower bed, statue, fountain, vase, fixture or ornament, fence, building or structure of whatsoever nature and kind without the prior written permission of the Director of Parks and Recreation.

594.2.11 Waste - disposal - in receptacles - provided

No person shall leave any waste of whatsoever nature and kind including bottles, breakable containers, ashes, and garbage, in any park or recreational area of the City of Sudbury except when same has been deposited by such person in waste receptacles placed in such park or recreational area for such purpose. By-law 76-100, 22 June, 1976.

594.2.11.1 Disposal - needles - syringes

No person shall place, deposit or abandon needles, hypodermic needles, syringes, intravenous tubing with needles attached, lancets, scalpel blades, razor blades, broken glass or other sharp objects in any park, city-owned property or road allowance. By-law 97-88, 13 May, 1997.

594.2.12 Hunting - fishing - in park - prohibited

No person shall hunt in any park or recreational area of the City of Sudbury.

594.2.13 Fishing - from - near - bathing area - prohibited

No person shall fish from, on or near any bathing area in any park or recreational area of the City of Sudbury.

594.2.14 Animals - injured - disturbed - in park - prohibited No person shall injure, hurt or otherwise molest or disturb any animal, bird or fish kept in any park or recreational area of the City of Sudbury or in the lakes or ponds in, connected with or adjacent to any park or recreational area of the City of Sudbury.

594.2.15 Operation - vehicle - areas - designated - by signs

No person shall operate a vehicle in any park or recreational area of the City of Sudbury except in those areas specifically designated by appropriate signs or notices as being areas in which vehicles may be operated.

594.2.16 Parking - areas - times - designated - by signs

No person shall park any vehicle in any park or recreational area of the City of Sudbury except in those areas specifically designated by appropriate signs and notices as being areas in which vehicles may be parked and then only when the park or recreational area concerned is in a period of operation and therefore open to the public and then only between the hours of 8 a.m. and 11 p.m. and then only for no longer than a reasonable length of time.

Article 3

PERIODS OF OPERATION

594.3.1 Established - signs posted - by Superintendent

The Director of Parks and Recreation shall establish each year the periods of operation for each and every park and recreational area in the City of Sudbury for that year and the Superintendent shall arrange to post at each of the entranceways to each park and recreational area a sign or signs indicating the period or periods during that year when that park or recreational area is in operation and therefore, open to the public.

594.3.2 Entrance - park - closed - permission - required

No person shall enter, be or remain in any park or recreational area of the City of Sudbury without the prior written permission of the Director of Parks and Recreation during any period of the year when that park or recreational area is not in operation and therefore not open to the public.

594.3.3 Summer - daytime - hours - 8 a.m. - 11 p.m.

During any period of operation when a park or recreational area is open to the public, the hours of operation for that park or recreational area on any day during that period shall be 8 a.m. - 11 p.m.

594.3.4 Entrance - park - closed - nighttime - permission

During any period of operation when a park or recreational area is open to the public no person shall enter, be or remain in any park or recreational area of the City of Sudbury without the prior written permission of the Director of Parks and Recreation during all or any part of the hours of 11 p.m. of one day to 8 a.m. of the next day.

Article 4 ANIMAL - CONTROL

594.4.1 Animals - in park - prohibited

Subject to Section 594.4.2, no person shall permit any animal belonging to him/her or in his/her custody, possession or control to enter, be or remain in any park or recreational area of the City of Sudbury.

594.4.2 Dog - cat - on leash - maximum length

No person shall permit any dog or cat belonging to him/her or in his/her custody, possession or control to enter, be or remain in any park or recreational area of the City of Sudbury except when such dog or cat, as the case may be, is on a leash held by such person and no greater in length than nine feet.

594.4.3 Dog - cat - restricted to - roads - walkways - footpaths Such persons as referred to in Section 594.4.2, shall restrict the movement of the dog or cat, as the case may be, to the roads, walkways and footpaths in such park or recreational area.

594.4.4 Excrement - removal device - responsibility

Such persons as referred to in Section 594.4.2, shall carry with him/her some sort of device to clean up any mess which the dog or cat, as the case may be, makes in the park or recreational area.

594.4.5 Excrement - removal - responsibility

Such persons as referred to in Section 594.4.2, shall clean up any mess which the dog or cat, as the case may be, makes in the park or recreational area and in doing so abides by Section 594.2.11 of the Chapter. 594.4.6 Animals - swimming - deposit by - in water - prohibited No person shall permit any animal belonging to him/her or in his/her custody possession or control to swim in or throw or deposit any injurious, noisome or offensive matter into the water and any reservoir, lake, pond or other receptacle for water in, connected with or adjacent to any park or recreational area of the City of Sudbury.

594.4.7 Animals - deposit by - on ice - prohibited

No person shall permit any animal belonging to him/her or in his/her custody, possession or control to throw or deposit any injurious, noisome or offensive matter upon the ice of any water in, connected with or adjacent to any park or recreational area of the City of Sudbury.

594.4.8 Animal - damaging - works - water - prohibited

No person shall permit any animal belonging to him/her or in his/her custody, possession or control, to foul the water or commit any unlawful damage or injury to the works, pipes or water or encourage same to be done in any park or recreational area of the City of Sudbury.

594.4.9 Animal - injuring - trees - plants - flowers - prohibited No person shall permit any dog or cat, as the case may be, belonging to him/her or in his/her custody, possession or control, to damage, break down, destroy or injure any tree, shrub, plant, flower or flower bed in any park or recreational area of the City of Sudbury.

Article 5 BATHING - REGULATIONS

594.5.1 Clothing - bathing suit - proper - required

No person shall in any park or recreational area of the City of Sudbury enter or bathe in any water in, connected with or adjacent to such park or recreational area without being properly clothed in a bathing suit.

594.5.2 Dress - undress - undesignated areas - prohibited

No person shall in any park or recreational area of the City of Sudbury dress or undress in or adjacent to any water in, connected with or adjacent to such park or recreational area except in those places specifically provided for such purposes.

594.5.3 Loitering - nuisance - in - near bathhouse - prohibited No person shall in any park or recreational area of the City of Sudbury loiter in any bathhouse or bathing station or conduct himself/herself in such manner as to be objectionable to other persons in or near any such bathhouse or bathing station.

594.5.4 Devices - dangerous - in water - at beach - prohibited No person shall in any park or recreational area of the City of Sudbury bring to any beach at such park or recreational area or into any water adjacent thereto, any device which may be dangerous or cause injury to other persons using the said beach or water including such devices as underwater spears or shooting devices.

594.5.5 Inflatable objects - toys - mattresses - balls - prohibited No person shall in any park or recreational area of the City of Sudbury bring to any bathing beach at such park or recreational area or into the water adjacent thereto any inflatable objects such as air toys, air mattresses, beach balls and tires.

594.5.6 Entry - bathhouse - opposite sex - prohibited

No person shall in any park or recreational area of the City of Sudbury being a male person, enter any portion of any bathhouse or bathing station set apart for the use of female persons or being a female person, enter any portion of any bathhouse or bathing station set apart for the use of male persons.

Article 6 ACTIVITIES - PERMITS - REQUIRED

594.6.1 Written permit - required - from Superintendent No person shall in any park or recreational area of the City of Sudbury do any of the things set out in Sections 594.6.2 through 594.6.9 inclusive without first receiving a written permit so to do from the Director of Parks and Recreation.

594.6.2 Perform - art - service - for reward - prohibited No person shall without a permit perform for reward any art, skill or service.

594.6.3 Pavement - sidewalk - grass - flower bed - digging up No person shall without a permit dig or tear up any pavement, roadway, sidewalk, crosswalk, footpath, pedestrian way, grass plot or flower bed.

594.6.4 Amplifying system - operation

No person shall without a permit operate any amplifying system or loud speaker.

594.6.5 Fires - lighting - building

No person shall without a permit light or build a fire.

594.6.6 Boats - mooring - beaching

No person shall without a permit moor or beach a boat.

594.6.7 Coin operated machines - operation

No person shall without a permit place or maintain any coin operated machine or game of whatsoever nature and kind.

594.6.8 Event - organized - maximum participation - 25

No person shall without a permit organize or arrange an event at which more than twenty-five persons are invited or are expected to attend.

594.6.9 Structures - erection - construction

No person shall without a permit erect, construct, build or cause to be erected, constructed or built, any structure of whatsoever nature and kind and without in any way limiting the generality of the word, "structure", includes, "tents", "shelters", "fences", and "buildings".

594.6.10 Permits - granted - terms - conditions - discretionary In granting a permit or permits to do any matter or matters set out in Sections 594.6.2 through 594.6.9 inclusive, the Director of Parks and Recreation may set such terms and conditions respecting the issuance of the permit as he/she in his/her sole discretion determines advisable.

594.6.11 Permit - authorization - areas - terms - designated

Should a person receive from the Director of Parks and Recreation a permit to do any one or more of the matters set out in Sections 594.6.2 through 594.6.9 inclusive, then such person shall do such matter or matters only:

- (a) in those areas designated by the Director of Parks and Recreation for the carrying on of such matter or matters; and
- (b) in accordance with any terms or conditions which the Director of Parks and Recreation sets on the issuance of the permit.

Article 7 AUTHORITY

594.7.1 Enforcement - officials - designated

The Sudbury Regional Police, the Municipal By-law Enforcement Officers of the City, the Director of Parks and Recreation or any of their designates are hereby authorized and requested to enforce this Chapter.

594.7.3 MAINTENANCE - OPERATION - MANAGMENT 594.9.1

594.7.3 Identification - production - on request - required Every person, when requested to do so by any person mentioned in Section 594.7.1, who is engaged in enforcing the provisions of this Chapter, shall produce reasonable identification of himself/herself, i.e. his/her correct name and address and his/her failure so to do is hereby deemed to be a contravention of this Chapter.

594.7.4 Failure - to leave park - when requested - prohibited Every person, when requested to do so by any person mentioned in Section 594.7.1, who is engaged in enforcing the provisions of this Chapter, shall leave the park or recreational area concerned and his/her failure so to do, is hereby deemed to be a contravention of this Chapter. By-law 76-100, 22 June, 1976.

Article 8 ENFORCEMENT

594.8.1 Fine - for contravention

Every person who contravenes any of the provisions of this Chapter is guilty of an offence and shall, upon conviction thereof, forfeit and pay a penalty of not more than five thousand dollars (\$5,000), exclusive of costs and every such fine is recoverable under the *Provincial Offences* Act. Article 9 ENACTMENT

594.9.1 Effective date

This Chapter comes into force and takes effect immediately upon the final passing of the enabling by-law. By-law 76-100, 22 June, 1976.

Background

The City offers significant community benefits in the form of programs, events and facilities by which private corporations may deem beneficial to support through financial or in-kind support in the advancement of their corporate social responsibility. These corporate partnerships can present as enhancement to existing assets, the delivery of special events, the creation of new facilities or the introduction of new programs and services. Corporate sponsorship improves and increases active living opportunities for City of Greater Sudbury residents which is in keeping with the Healthy Community priority of City Council.

A number of municipalities have defined corporate sponsorship policies. The following is a highlight of researched corporate sponsorship policies and programs:

City of Kingston

The City of Kingston has adopted both a Corporate Sponsorship Policy as well as a Advertising Revenue Generation Policy which govern corporate relationships for paid advertising and sponsorship.

City of Ottawa

The City of Ottawa has identified sponsorship and advertising opportunities and associated anticipated revenues through 2015. Opportunities include program sponsorship, naming rights, special events sponsorship and facility signage advertising with a total revenue potential of \$12.7 million by 2015.

City of Toronto

The City of Toronto pursues a number of corporate sponsors to help deliver programs and events such as Doors Open Toronto and the annual Bike Month program. The City of Toronto generated \$35.8 million in sponsorship and advertising revenue in 2009. City of Toronto Council is currently considering a formal sponsorship and naming rights policy.

City of Whitby

The City of Whitby has utilized corporate sponsorship of recreation facilities, naming rights and event sponsorship to enhance facilities and keep program rates affordable. In 2009, the City of Whitby generated \$442,500 in sponsorship and advertising revenue.

City of Winnipeg

The 'Sponsor Winnipeg' program provides opportunities for sponsorship of greenspace, parks, special events, recreation facilities, transportation, social services and animal services. The program generated \$500,000 in sponsorship revenue in 2009 and is managed through the Office of the Mayor.

City of Sudbury

Prior to amalgamation, the City of Sudbury successfully developed and promoted a "Careshares" program that invited businesses, organizations, volunteer associations and community members to contribute funds towards enhancing the quality of life in their communities. The focus of the program centred on beautification projects; however, there were also opportunities for corporate contributions for youth programs and special events. Donor recognition was made through the Leisure Guide, local media coverage and invitations to the annual Community Sponsorship Recognition and Awards Ceremony.

Since amalgamation, the City has worked with the private sector for the enhancement of facilities, programs and events. Examples include the sponsorship of new creative play structures at local playgrounds, investment in infrastructure at Adanac Ski Hill, event support for the annual Volunteer Recognition Picnic and the 2010 Ontario Summer Games.

A Corporate Sponsorship Policy will ensure that future sponsorship relationships are consistent with the City of Greater Sudbury's vision and mission, comply with City policies and where sponsorship opportunities exceed a financial benefit of over \$35,000 a competitive process will be undertaken.

General Principles of the Corporate Sponsorship Policy

The City of Greater Sudbury supports the principle that external corporations may sponsor portions of or entire City programs, events and facilities where such sponsorship is mutually beneficial to both parties and is consistent with the City's vision and mission, City policies and by-laws.

For sponsorship opportunities exceeding \$35,000, a competitive process will be undertaken.

Types of Sponsorships Opportunites

Potential partnership opportunities include:

<u>Program and Service Sponsorship</u>: sponsorship of new and existing programs, including: adult, aquatic, fitness, skating, skiing, snowboarding and youth programs.

<u>Event Sponsorship</u>: sponsorship of existing annual events organized and delivered through Leisure Services, for example, the Bell Park Concert Series and the Annual Volunteer Recognition Picnic.

<u>Facility Enhancements</u>: The sponsorship of assets which will enhance the quality and experience of Leisure Services facilities and parks. Enhancements include, but are not limited to new creative play structures and playground equipment, sun shelters, benches and support buildings.

<u>Community Information Boards</u>: The sponsorship of existing and new billboards used to promote community events and activities.

<u>Interior Signage (LED Screens)</u>: The sponsorship of interior signs and LED screens for city and community messaging at community centres, pools, arenas and other facilities. (existing agreement regarding Sudbury Community arena/local community arenas)

Due to the complex nature of Naming Rights , it is recommended that these are dealt with outside the scope of the Sponsorship Policy. Naming Rights are considered in a commercial context, where the naming right is sold or exchanged for significant cash and/or other considerations under a long-term agreement. Staff will be bringing forward updates to the Building, Property and Park Naming Policy, By-law 2004-303 to City Council regarding new recommended processes for building and facility naming. Pouring Rights agreements typically also include exlusive rights for the provision of beverages or other services, beyond a sponsor recognition agreement. Existing Pouring Rights agreements at City of Greater Sudbury facilities are done through a competitive process.

Advertisements within printed materials produced by the City of Greater Sudbury also fall outside the scope of this policy as advertising space is sold at established rates and does not imply any reciprocal partnership arrangement.

Corporate Sponsorship Policy

Purpose

The purpose of the Corporate Sponsorship Policy is to provide an opportunity for businesses to make financial contributions towards programs, events, services or facilities in return for public recognition.

<u>Scope</u>

If the value of the public recognition contribution is over \$35,000 a competitive process will be undertaken.

Definition

Corporate Sponsorship: A mutually beneficial business arrangement between the municipality and an external company wherein the external party contributes funds to a municipal program, event, service or facility in return for recognition, acknowledgement or other promotional consideration.

Policy Guidelines

Corporate Sponsorships must:

- respect and comply with City of Greater Sudbury policies, by-laws and plans;
- be consistent with the City of Greater Sudbury Visual Identity Program;
- support the City of Greater Sudbury's vision and mission.

The Corporate Sponsorship Policy excludes:

- corporations that are not in good standing with the municipality;
- businesses which derive revenue from the production of tobacco or alcohol products (except events and facilities licensed under the LLBO);
- funding obtained through formal government programs from other levels of government;
- donations received under the Parks Services Donation and Memorial Program (By-law 2011-152);
- third parties who lease City of Greater Sudbury properties or hold facility agreements with the City of Greater Sudbury for activities or events; and
- existing advertisement agreements that the City of Greater Sudbury has entered into through a competitive process.

The Corporate Sponsorship Policy does not:

- imply endorsement of businesses, products or services;
- relinquish control of program and service delivery, event planning or facility management; or

• include Naming Rights, Pouring Rights or advertisements within printed material produced by the City of Greater Sudbury.

Recognition of Corporate Sponsors will:

- be consistent with the proposed sponsorship of the program, event or facility in question;
- designed in a manner not to detract from the physical attributes and visual integrity of the facility or event/program location; and
- must not negatively impact the experience of users of sponsored events and facilities.

Sponsor Solicitation and Processes

The solicitation of sponsorships shall be conducted in a manner that enhances access and fairness and results in a mutually beneficial agreement for both the City, residents of the City of Greater Sudbury and the corporate sponsor.

Corporate sponsors will advise the CAO and appropriate General Manager in writing of interest in potential sponsorship agreements.

City staff shall be specifically designated by the appropriate General Manager to meet with potential sponsors to discuss arrangements and expectations.

Sponsorships valued less than \$35,000 may be considered when brought forward to the City.

A competitive process will be undertaken for any sponsorship over \$35,000 or those sponsorships that offer a significant corporate profile.

Departments will establish the level and manner of sponsor recognition through the negotiation process associated with each sponsorship agreement.

Any costs to the City associated with a corporate sponsorship must be within approved operating and capital budgets.

Approved corporate sponsorships will be confirmed with a written agreement. Agreements will include at minimum the following:

- The program, service, event or facility in question
- The value of the sponsor contribution
- Obligations for sponsorship recognition
- Responsibility for maintenance, insurance, etc. of any assets associated with or resulting from a corporate sponsorship
- The term of the sponsorship agreement

• Specific plans for marketing and branding of the program, service, event or facility in question

Written corporate inquiries denied sponsorship approval will be advised in writing with a detailed rationale.

The City of Greater Sudbury reserves the right to reject any unsolicited sponsorships that have been offered to the City and to reject any proposals for sponsorship that have been openly solicited by the City.

Termination of Sponsorship Agreements

The City reserves the right to terminate a sponsorship agreement under the following circumstances:

- the sponsor in question uses the City's name outside the parameters of the sponsorship agreement, without prior consent;
- the sponsor in question develops a public image which conflicts with the City's vision, mission and services.

<u>Term</u>

Corporate sponsorship agreements will not exceed the program or service cycle, the event duration or the life of the asset in question.

Corporate Sponsorship Policy

<u>Purpose</u>

The purpose of the Corporate Sponsorship Policy is to provide an opportunity for businesses to make financial contributions towards programs, events, services or facilities in return for public recognition.

Corporate sponsors will advise the CAO and appropriate General Manager in writing of interest in potential sponsorship agreements.

City staff shall be specifically designated by the appropriate General Manager to meet with potential sponsors to discuss arrangements and expectations.

Sponsorships valued less than \$35,000 may be considered when brought forward to the City.

A competitive process will be undertaken for any sponsorship over \$35,000, in accordance with the threshold identified in the Purchasing By-law, or those sponsorships that offer a significant corporate profile.

The competitive bid process threshold for Corporate Sponsorship will mirror any revisions made in the Purchasing By-law.

Departments will establish the level and manner of sponsor recognition through the negotiation process associated with each sponsorship agreement.

Any costs to the City associated with a corporate sponsorship must be within approved operating and capital budgets.

Approved corporate sponsorships will be confirmed with a written agreement. Agreements will include at minimum the following:

- The program, service, event or facility in question
- The value of the sponsor contribution
- Obligations for sponsorship recognition

- Responsibility for maintenance, insurance, etc. of any assets associated with or resulting from a corporate sponsorship
- The term of the sponsorship agreement
- Specific plans for marketing and branding of the program, service, event or facility in question

Written corporate inquiries denied sponsorship approval will be advised in writing with a detailed rationale.

The City of Greater Sudbury reserves the right to reject any unsolicited sponsorships that have been offered to the City and to reject any proposals for sponsorship that have been openly solicited by the City.

Termination of Sponsorship Agreements

The City reserves the right to terminate a sponsorship agreement under the following circumstances:

- the sponsor in question uses the City's name outside the parameters of the sponsorship agreement, without prior consent;
- the sponsor in question develops a public image which conflicts with the City's vision, mission and services.

<u>Term</u>

Corporate sponsorship agreements will not exceed the program or service cycle, the event duration or the life of the asset in question, and are negotiated with private sector partners and CGS.

Recommendation

And whereas that Operator did remit payment for the 2010 arrears;

Be it resolved that the Standing Committee of Community Services recommend an operational review of Walden Day Care Centre in order to establish timelines and capacity for re-payment and determine the sustainability of the Centre.

Finance Implications

If an operational review is required, the funding would be provided for within the existing operating budget.

Background

The Children Services Section oversees the children services system in Greater Sudbury and as such administers two key programs for child care providers. Wage subsidy is a program in which the City will reimburse staffing costs based on a Provincial formula. Fee subsidy allows citizens to access a subsidy based on income testing that allows equitable access to the child care system.

Currently the City manages wage subsidy agreements with 23 different providers. The formula that is used to calculate wage subsidy at the beginning of the year is based on the specific operating capacity of the Centre. As part of the administrative process, the City requires an annual reconciliation from providers in order to ensure the wage subsidy funds are being used for their intended purpose. As an example, a

Doug Nadorozny Chief Administrative Officer Digitally Signed Feb 15, 12 provider could have a reduction in operating capacity during the year which would then cause an overpayment which the provider would have to pay back to the City. Providers have been instructed to complete monthly reconciliations as part of good business practice to ensure that they catch any overpayment's early in the year and that these can then be corrected which avoids a large overpayment at the end of the year.

For 2010 and 2011, there has been one organization that has had large overpayment's owed to the City at year end. Walden Day Care Centre (WDC) owed the City \$34,077 for the 2010 wage subsidy which was repaid on December 30th, 2011 after making an arrangement with the City.

The reconciliation for 2011 wage subsidy was due by the end of January 2012 which showed an amount owing to the City of \$24,387. WDC has indicated that they could only afford to pay back the amount on a monthly basis over the next 24 months, which is outside of the City's practice.

A Brief History of Walden Day Care Centre

WDC has been in operation since 1989 and has had various interactions with the City throughout the past 10 years. WDC is currently licensed to provide 349 spaces in four sites and is the only operator providing English language licensed child care in the Copper Cliff and Lively areas. On two separate occasions the City has conducted reviews of different facets of the Centre's operations. The outcome in both instances resulted in recommendations which were presented to the Board of Directors of the Centre.

CGS Considerations for Walden Day Care Centre

The City of Greater Sudbury has two options to collect the outstanding balance;

1. Complete an operational review to establish time lines for re-payment and assess sustainability of the Centre.

The City of Greater Sudbury can appoint a 3rd party to review the current operations at the Centre. This would give the City a clear understanding of the financial condition of the Centre and would therefore allow the City to be prepared with a contingency plan if there was indeed a default by the Centre. The report would be shared with the Board of Directors at the Centre. The selection of a 3rd party auditor would follow the City's purchasing policies and procedures. KPMG has done this type of work for the Children Services Section in the past and they have a familiarity with this Centre and the funding guidelines for Children Services. The 3rd party would also recommend a re-payment plan based on their analysis of the long term sustainability of the Centre. The total cost of the option would be in the range of \$10,000 to \$15,000. This would be funded from the administrative portion of the Children Services budget that is fully funded from the Ministry of Education.

2. Commence overpayment reductions on their monthly payments from the City to bring the debt to zero by year end.

The City of Greater Sudbury could commence overpayment reductions by clawing back the monthly wage subsidy that is owed to the Centre to establish a re-payment plan to recover the funds, within the fiscal year ending December 31st, 2012.

While this option would collect the amount owing in a timelier manner, it will not address the root problem of ongoing payment issues with the Centre and may put the Centre at risk- jeopardizing the delivery of child care services in the Lively area.

Next Steps

It is recommended that Option 1 be implemented in order to establish a repayment plan that is

recommended by an outside party based on the financial condition of the Centre. This option will also allow Children Services to be able to protect the child care spaces in the area with an adequate contingency plan should the Centre default. It will also provide the operator with recommendations to manage City subsidies in a more efficient manner.

Finance Implications

If approved, the funding for the feasibility study will be provided for from the operating budget and a contribution from the Land Ambulance Reserve Fund.

Executive Summary

The Emergency Services Department, working with Police Services and the Office of the CAO, should jointly investigate the feasibility to integrate EMS dispatch with the City's current dispatch system for 9-1-1, Police and Fire, to achieve a fully integrated Emergency Communications Services system for the Greater City. This should include development of a 'phased' implementation plan (inclusive of capital and operating costs) and a Business Case for the Community Services Committee/Council's consideration and submission to the Ontario Ministry of Health and Long Term Care. Phase 1 of the implementation plan may be the City's assumption of operational governance (100% provincially funded) for ambulance dispatch.

Background

In the Province of Ontario, the Ministry of Health and Long Term Care (MOHLTC) has had responsibility for all aspects of ambulance communications, including the answering and processing of incoming requests for

ambulance service, the assignment of ambulances to emergency and non-emergency calls and, traditionally, the deployment of available resources within the requirements of the municipalities' deployment plan (Pomax Inc, 2009).

In the North, there are two Central Ambulance Communications Centres (Sudbury & Thunder Bay) operated by the MOHLTC, and another three centres located in Timmins (Police), Sault Ste. Marie (Hospital), and North Bay (Hospital) that are operated as non-ministry dispatch centres. The MOHLTC currently provides 100% of operating to non-ministry dispatch centres in the Province.

For the City's Emergency Medical Services, the City relies on the Sudbury Central Ambulance Communications Centre (CACC) located at McFarlane Lake (3767 Highway 69 S) operated by the MOHLTC; whereas, Greater Sudbury Police Services provide 9-1-1 and emergency dispatch services for the Police and Fire Services.

The two agencies (CACC and Police Communications) operate independently from separate locations, using different staff, CAD/COM systems, operating protocols, standards, etc. The lack of interoperability of communications impedes information sharing and contributes to operational inefficiency and occasional delay in deployment of the correct resource. Further, there is an overlap of Fire and EMS responsibilities frequently resulting in deployment of resources from both Services when they may not be required e.g., medical aid calls. Also called into question is the quality of EMS dispatch call data records, which the City receives through governmental third party services, external to the MOHLTC Emergency Health Services Branch.

There are more streamlined models for public safety dispatch that other jurisdictions have implemented, ranging from physical co-location of dispatch services, to partial consolidation of functions, to complete integration. It has been suggested that the City should investigate assumption of operational governance for ambulance dispatch services – as is the case in the City of Toronto, City of Ottawa and in the Regional Municipality of Niagara.

The Regions of Peel, Durham, York, and Halton, and the County of Simcoe have undertaken a joint feasibility study and the findings have recommended taking the necessary steps to convince the Province that governance and operational responsibility for land ambulance dispatch services in the Greater Toronto Area should be transferred to the municipalities as a single GTA Dispatch centre model. And further, that the Province should assume a legislative, regulatory, and continued funding role only.

In Sudbury, given that the City's Emergency Medical Services call volumes represents about 90% of the work assignment for the Sudbury Central Ambulance Communications Centre, there is a further opportunity to investigate the feasibility to integrate EMS dispatch with the City's current dispatch system for 9-1-1. Based on the findings to date, the City of Timmins is the only dispatch centre that has responsibility for all three emergency services (Police, Fire, and EMS) throughout the Province.

The Chief of Emergency Services working with Police Services and the Office of the CAO will, with the assistance of third party subject matter expertise, develop a Business Case for the City's Community Services Committee/Council's consideration and submission of the Ontario Ministry of Health and Long Term Care.
