Presentations

1. Report dated February 22, 2012 was received from the General Manager of Infrastructure Services regarding Pedestrian Crossing Policy and Recommendations.

David Shelsted, Acting Director of Roads & Transportation, introduced Chris Philp, Vice-President, HDR/iTrans, who made an electronic presentation regarding the Pedestrian Crossing Policy Study.

Chris Philp explained the policy objectives, crossing alternatives, best practices and the recommended pedestrian crossing policy reviewed in the study. He provided highlights of three pedestrian crossing reviews: Elm Street, Brady Street and Ste. Anne Road.

The following recommendations were presented:

OP2012-14 Caldarelli/Berthiaume: THAT the City of Greater Sudbury adopt the Pedestrian Crossing Policy prepared by HDR Corporation dated February 2012.

OP2012-24 Berthiaume/Caldarelli: THAT the City of Greater Sudbury prohibit parking on both sides of Paquette Street from Lasalle Boulevard to 80 metres north of Lamothe Street, between the hours of 8:00 a.m. and 4:30 p.m., Monday to Friday;

AND THAT the City of Greater Sudbury prohibit parking on the west side of Bulmer Avenue from Lorne Street to Mary Street;

AND THAT the City of Greater Sudbury prohibit parking along both sides of Pine Cone Road from 725 metres northeast of East Bay Road to 950 metres northeast of East Bay Road;

AND THAT the City of Greater Sudbury prohibit parking on the east side of Pine Cone Road from 950 metres northeast of East Bay Road to 1,100 metres northeast of East Bay Road;

AND THAT the City of Greater Sudbury pass a by-law to amend Traffic and Parking By-Law 2010-1 in the City of Greater Sudbury to implement the recommended changes in accordance with the report from the General Manager of Infrastructure Services dated February 22, 2012.
