Dheera Kantiya, MTO Project Manager, introduced the subject and Gregg Cooke, Stantec Project Manager, made an electronic presentation regarding the Route Planning and Environmental Assessment Study, Highway 17 from Sudbury to Markstay and Highway 69 from Estaire Road to Highway 17.
