Presentations

 Report dated November 17, 2011 from the Chief Financial Officer/Treasurer and the General Manager of Infrastructure Services regarding 2012 Water and Wastewater Overview (Operating & Capital Budget) was distributed to Committee Members at the meeting.

Greg Clausen, General Manager of Infrastructure Services; Nick Benkovich, Director of Water/Wastewater Services and Lorella Hayes, Chief Financial Officer/Treasurer made an electronic presentation regarding the proposed 2012 Water/Wastewater Budget.

The General Manager of Infrastructure Services presented an infrastructure map and listed the number of facilities and lift stations throughout the City. He outlined the Capital Budget, accomplishments and challenges of Water/Wastewater Services. He also outlined capital upgrades and renewals to the water distribution system, wastewater collection system and rehabilitation program.

The Director of Water/Wastewater Services provided highlights of the system maintenance activities of 2011. He outlined performance measures and 2008 to 2010 comparisons to the OMBI Performance Measures. He stated that this service is funded solely by user fees and consumption has declined across Ontario leading to budget challenges. He indicated the 1.5% Base Budget increase is below inflation. He explained their detailed budget review, Business Improvement Study, operational optimization, source control, inflow and infiltration reduction, non-revenue water reduction and bulk water dispensing sites. He outlined the proposed 2012 Operational Budget allocations and water/wastewater rate history since 2002. He concluded with the proposed enhancement options.

Recess

At 5:30 p.m. Council recessed.

Reconvene

At 6:03 p.m. Council reconvened.

The Chief Financial Officer/Treasurer explained in detail the sources of revenue, fixed versus variable costs and consumption declines. She outlined the 2012 Base Budget rates and increases. She advised of the conclusions from the 2010 Rate Study Review. She explained the fixed monthly meter charges, the existing policy for fixed meter rates and equivalency ratios relative to two other benchmarks. She presented two options: staff recommendation or status quo. She advised of the impact of the recommendation on typical residences and on high volume customers. She outlined the budget enhancements and the options for residential increases. She concluded with the next steps being direction from the Committee regarding Monthly Fixed Service Charges and voting on enhancement options on December 5, 2011 and approval of the Water/Wastewater By-law by Council on December 14, 2011.
