# Presentations

1. Report dated October 27, 2011 was received from the Auditor General regarding 2012 Proposed Audit Workplan.

Brian Bigger, Auditor General, gave an electronic presentation regarding 2012 Proposed Audit Workplan. He reviewed the 2012 Audit Workplan and how resources allocated to the Auditor General's Office may be used during 2012. He identified where audit or review procedures are expected to present the greatest organizational value for the time committed. He stated he is seeking feedback from the Committee regarding the proposed audits, potential audits and the desired order of completion. He also reviewed the 2010 to 2011 Audits that have been completed and listed the proposed 2012 Audits and potential future audits.

The following motion was presented:

2011-29 Matichuck-Barbeau: THAT the Audit Committee direct the Auditor General to reprioritize his proposed 2012 Audit Workplan to reflect the requests of the Audit Committee regarding priorities as described during the course of the meeting of November 2, 2011;

AND THAT the Auditor General report back with a revised 2012 Audit Workplan.

The priorities of the Committee are:

- Water and Wastewater, Emergency Construction Activities; Falconbridge ISF Roads Project, Value for Money and Control;
- Waste and Recycling; .
- Impact to Changes to Road Design (Asphalt Grindings and Road Cross-fall);
- Construction Management, Warranty and Acceptance;
- User Fee Shift in Funding Sources.

2. Report dated October 27, 2011 was received from the Auditor General regarding the Auditor General's Cost Centre - 2011 Year End Closing Procedures.
