## Public Hearings

- 1 . Report dated June 20, 2011 was received from the General Manager of Growth and Development regarding Naming of Private Roads.

Letter dated May 18, 2011 from Robert Johnston, CEO, Greater Sudbury Airport, was distributed to Committee Members at the meeting.

Robert Johnston, CEO, Greater Sudbury Airport explained Emergency Services, Canada Post, etc. have no way of identifying specific locations at the airport. The Greater Sudbury Airport Board feels the naming and numbering of the private roads would benefit the tenants as the airport area continues to develop.

The following recommendation was presented:

Rivest-Kett: THAT the private existing road legally described as Part of PIN 73512-0004, part of Parcel 53333 S.E.S., Lot 10, Concession 6, Township of Falconbridge & Lot 10, Concession 1, Township of MacLennan, to and from Skead Road, Greater Sudbury Airport, City of Greater Sudbury be named promenade Air Terminal Drive;

AND THAT the private existing road legally described as Part of PIN 73512-0004, part of Parcel 53333 S.E.S., Lots 10 & 11, Concession 6, Township of Falconbridge, from Skead Road to north-west extent, Greater Sudbury Airport, City of Greater Sudbury be named cour Hangar Court;

AND THAT the private existing road legally described as Part of PIN 73512-0004, part of Parcel 53333 S.E.S., Lots 10 & 11, Concession 6, Township of Falconbridge, from Air Terminal Drive to south-west extent, Greater Sudbury Airport, City of Greater Sudbury be named promenade Skyline Drive;

AND THAT the proposed private road legally described as Part of PIN 73512-0004, part of Parcel

53333 S.E.S., Lots 9 & 10, Concession 1, Township of MacLennan, from Navion Road to north extent, Greater Sudbury Airport, City of Greater Sudbury be named chemin Aviation Road;

AND THAT the proposed private road legally described as Part of PIN 73512-0004, part of Parcel 53333 S.E.S., Lots 9 & 10, Concession 1, Township of MacLennan, from Aviation Road to north-west extent, Greater Sudbury Airport, City of Greater Sudbury be named chemin Delta Road;

AND THAT the proposed private road legally described as Part of PIN 73512-0004, part of parcel 53333 S.E.S., Lots 9 & 10, Con. 1, Twp. of MacLennan, from Air Terminal Drive to north-west extent, Greater Sudbury Airport, City of Greater Sudbury be named chemin Navion Road;

AND THAT the proposed private road legally described as Part of PIN 73512-0004, part of Parcel 53333 S.E.S., Lots 9 & 10, Concession 1, Township of MacLennan, from Aviation Road to north-west extent, Greater Sudbury Airport, City of Greater Sudbury be named chemin Sierra Road;

AND THAT the proposed private road legally described as Part of PIN 73512-0004, part of Parcel 53333 S.E.S., Lot 9, Concession 1, Township of MacLennan, from Aviation Road to north-west extent, Greater Sudbury Airport, City of Greater Sudbury be named chemin Tango Road.

AND THAT the necessary by-law be passed.

The Committee was advised that the proposed roads should not be named until they have been constructed. The names of the proposed roads would be reserved until that time.

Councillor Rivest stated that chemin Aviation Road and chemin Navion Road sound similar and may cause confusion. After discussion, the Committee agreed that the road under construction would be named chemin Aviation Road rather than chemin Navion Road.

The Committee noted that three roads are existing and the fourth road is under construction (cour Hanger Court, promenade Skyline Drive, promenade Air Terminal Drive and chemin Aviation Road). The Committee further noted that the remaining suggested street names (chemin Navinon Road, chemin Delta Road, chemin Sierra Road and chemin Tango Road) be reserved for future use as development occurs.

### Amendment

AND THAT the private existing road legally described as Part of PIN 73512-0004, part of Parcel 53333 S.E.S., Lots 10 & 11, Concession 6, Township of Falconbridge, from Air Terminal Drive to south-west extent, Greater Sudbury Airport, City of Greater Sudbury be named promenade Skyline Drive;

AND THAT the proposed private road legally described as Part of PIN 73512-0004, part of Parcel 53333 S.E.S., Lots 9 & 10, Concession 1, Township of MacLennan, from Air Terminal Drive Road to north extent, Greater Sudbury Airport, City of Greater Sudbury be named chemin Aviation Road;

AND THAT the following road names shall be reserved for future development for Greater Sudbury Airport;

- chemin Delta Road;
- chemin Navion Road;
- chemin Tango Road;
- chemin Sierra Road;

AND THAT the necessary by-law be passed.

2011-01 Rivest-Kett: THAT the last five paragraphs be deleted and replaced by:

AND THAT the proposed private road legally described as Part of PIN 73512-004, part of Parcel 53333 S.E.S., Lots 9 and 10, Concession 1, Township of MacLennan, from Airport Terminal Drive to north extent, Greater Sudbury Airport, City of Greater Sudbury, be named chemin Aviation Road;

AND THAT the following road names be reserved for future development for Greater Sudbury Airport;

- chemin Delta Road;
- chemin Navion Road;
- chemin Tango Road;
- chemin Sierra Road;

AND THAT the necessary by-law be passed.
