Presentations

Report dated January 20, 2011 was received from the Auditor General regarding Shift Transfers -1. Controls Over Distribution and Compensation of Work.

> Brian Bigger, Auditor General, made a verbal presentation regarding Shift Transfers - Controls Over Distribution and Compensation of Work within various departments of the City of Greater Sudbury Pioneer Manor, Emergency Services, Fire Services and Transit Services. He stated that weaknesses in controls were identified in the recording and tracking of shift transfers within two departments – Fire Services and Transit Services. Pioneer Manor and Emergency Services were well controlled. He indicated the following four issues were brought forward in the report:

- 1. The need to discontinue the practice of 'selling' shifts for cash within Transit Services;
- Shift trading must be done in a manner that is controlled and documented;
- The lack of a requirement to have the Inspector sign and confirm the accuracy of all timecards;
- 4. Shift transfers should not remain outstanding for more than two months.

He advised the audit ratings indicate that Transit Services requires attention, Fire Services is acceptable and Pioneer Manor and Emergency Services is strong. He concluded by stating that a follow-up will occur within three months for Transit Services and Fire Services follow-ups will be conducted semi-annually. The follow-up reports will be presented to the Audit Committee. The following motion was presented:

THAT the Audit Committee accept the report dated January 20, 2011 from the Auditor General identifying audit issues and the steps taken by Staff to resolve them, including the adequacy of management responses to audit concerns.
