COMMUNITY DELEGATIONS

Item 1 Update on Lacrosse in Greater Sudbury John Grant, representing the Greater Sudbury Lacrosse Association (GSLA) and the Ontario Lacrosse Association's Grassroots Committee, provided an update on lacrosse in Greater Sudbury. He stated that lacrosse has grown to a solid base of 500 players aged 5 to 21. The success of the Sudbury program has brought first place showings in all age groups at several tournaments across the province, interest from other regions of Canada and some international exposure. He listed some of the accomplishments of the GSLA. He stated that lacrosse brings visitors to the City who spend money on food, accommodation, shopping, etc. He stated there is a need for a centrally located multi-pad facility to provide a home base from which visiting families can plan other activities, to complement the local economy and to support the growth of youth sports. He indicated the need for a place to showcase our rich sporting culture. The vision of a Sports Hall of Fame needs to be a reality in one of our showcase sporting venues.

Update on Nurse
Practitioner Clinics and
Progress Report on
Lively Clinic

Marilyn Butcher, Clinic Director, Sudbury and District Nurse Practitioner Clinics, made an electronic presentation to provide Council with an update of their operation. She stated that Nurse Practitioners are authorized as regulated health professionals under legislation since 1998 to prescribe drugs, diagnose illness, order lab tests, ultrasounds, mammograms, pronounce death (controlled acts) and work in collaboration with other health care professions. She advised the multi-disciplinary clinic model was created over time as a result of practice experiences and has a community based Board of Directors. The evolution of the model is based on practice experiences in Sudbury and they have opened sites in Chapleau and Sudbury and plan to open in Lively in 2010. She outlined their corporate structure and their teaching practices in mentoring students. She advised of the announcement to roll out 25 additional Nurse Practitioner Clinics in Ontario based on the Sudbury model. She provided information on patient profile and patient satisfaction. explained the challenges including the lack of payment model for physicians, lack of recognition that they need clerical support and space issues. She outlined their partnership with the City of Greater Sudbury. To view the status of the Lively Clinic, she referred the Committee to www.sdnpc.ca.

Paul Seccaspina, CEO, OraclePoll Research, made an electronic presentation to provide the Committee with a summary of the findings of the Residential Survey. He stated the objective of the survey was to gauge the opinions of residents of the City on a series of issues related to life in the community, services delivery Where applicable, the results were and budget issues. compared to the results of the 2004 survey. He advised the data was collected from 1200 randomly selected residents over 18 years of age and the data was collected using Computer Assisted Telephone Interviewing. He indicated the first general area was the community's future and presented the results of questions regarding quality of life, confidence areas, changing community and the most important issues facing the community. Another area was healthy community with questions on healthy community living and healthy community initiatives. participatory democracy/communication, he reported auestions regarding municipal politics and municipal communications. With respect to the category of City Services, he provided results on the importance of certain services and the rating of performance of the services. He concluded by providing results of questions regarding the 2010 Budget and municipal tax increases.
