Report Summary

This report provides a recommendation regarding the proposed Terms of Reference for the Lively Recreation Advisory Panel.

Resolution

THAT the City of Greater Sudbury approves the terms of reference for the Lively Recreation Advisory Panel as outlined in the report entitled "Lively Area Recreational Amenities Advisory Panel Terms of Reference" from the Chief Administrative Officer presented at the City Council meeting on July 14, 2021.

Relationship to the Strategic Plan, Health Impact Assessment and Community Energy & Emissions Plan (CEEP)

This report supports Council's Strategic Plan in the area of Strengthening Community Vibrancy by involving community groups and community members to collaborate in the project leading to outcomes that make residents integral to, and engaged in, the project's success.

The process outlined in this report will reflect the Community Energy and Emissions Plan (CEEP). In particular, all recommendations emanating from this process will consider the goals outlined in the CEEP, as revised in March 2021.

Financial Implications

Costs associated with the implementation of the advisory panel will be covered by the existing 2021 operating budget in the Leisure Services and Communications and Community Engagement Divisions.

Background

At the September 22, 2020, Council meeting Vale Canada presented a proposal to purchase Meathird Lake from the City of Greater Sudbury. The purchase would allow Vale to undertake tailings dam improvements, including an erosion control project located near the park. It also affords Vale the opportunity to perform

environmental remediation work on the site and to discontinue pumping potable water to the lake, resulting in water conservation.

Additional conversations regarding the sale of the land were held in closed session in accordance with the Municipal Act, which permits closed discussions regarding real estate matters.

The sale of Meatbird Lake Park was finalized on May 7, 2021. The agreed upon price for the property was \$4 million which will be reinvested in recreation projects in Lively. A community engagement process will play an important part in determining specific plans.

At the June 29, 2021 City Council meeting, Council approved the engagement approach and directed staff to proceed with next steps in the process.

The creation of a Council-appointed citizen advisory panel will ensure residents of Lively play an active role in the determination of recreational amenities in their community. This report presents the Terms of Reference under which the committee will operate.

Terms of Reference

Mandate

To serve as a link between the City of Greater Sudbury, various stakeholders and the community at large, in the development of a plan ensuring future recreational amenities in Lively reflect local needs in alignment with Council's strategic priorities.

Primary Objectives

To advise municipal staff on new or upgraded recreation opportunities that will meet the needs of the Lively community and that supports the creation of a plan for applying the proceeds from the sale of Meatbird Lake Park.

To provide input and insight on location development or improvements for recreation infrastructure.

Assist city staff in preparation of final recommendations to Council.

Membership

The committee will be comprised of 10 members.

- 7 citizens as appointed by Council, including:
 - 2 Lively residents who are youth (12 to 18)
 - A Lively resident who is a parent/guardian (child/children under 18)
 - A Lively resident who is an older adult
 - 2 community members
 - A member of an active Lively area neighbourhood association or community group
- The Ward Councillor
- The Director of Leisure Services
- A staff member of the Communications and Community Engagement section

Time Commitment

The Lively Recreation Advisory Panel will meet monthly with additional meetings scheduled as required, until its mandate is complete. This Advisory Panel will serve until a final recommendation is approved by Council.

Next Steps

The application process for the Lively Recreation Advisory Panel membership will commence following the adoption of the Terms of Reference by-law. Information about the application process will be shared with the community as well as through numerous stakeholder groups.

The Nomination Committee meeting will take place following the application process with the advisory panel holding its first meeting shortly thereafter.

Recommendations to City Council will be presented in the fall of 2021. It is anticipated that further consultation with the community will then occur, particularly within Lively, about the recommendations.
