# A By-law of the City of Greater Sudbury to Confirm the Proceedings of Council at its Special Meeting of June 25, 2024 and its Regular Meeting of July 9, 2024

**Whereas** Section 5 of the *Municipal Act, 2001*, S.O. 2001, Chapter 25, as amended, requires a municipal Council to exercise its powers by By-law except where otherwise provided;

**And Whereas** in many cases, action which is taken or authorized to be taken by Council or by a Committee of Council does not lend itself to an individual By-law;

**And Whereas** Council of the City of Greater Sudbury deems it desirable to confirm certain proceedings of Council;

#### Now therefore Council of the City of Greater Sudbury hereby enacts as follows:

- 1. The actions of Council at its special meeting of June 25, 2024 and its regular meeting of July 9, 2024 with respect to each motion, resolution and other action passed and taken by Council at the said meeting, are hereby adopted, ratified and confirmed as if such proceedings and actions were expressly adopted and confirmed by By-law.
- 2. Where no individual By-law has been or is passed with respect to the taking of any action authorized in or by the above-mentioned minutes or with respect to the exercise of any powers by Council in the above-mentioned minutes, this By-law shall be deemed for all purposes to be the By-law required for approving and authorizing and taking of any action authorized therein or thereby, or required for the exercise of any powers therein by Council.
- 3. The Mayor of Council and the proper officers of the City are hereby authorized and directed to do all things necessary to give effect to the said actions or to obtain approvals where required, and, except where otherwise provided, the Mayor and Clerk are hereby authorized and directed to execute all necessary documents and to affix the corporate seal of the City to all such documents.

A By-law of the City of Greater Sudbury to Amend By-law 2017-22 being a By-law of the City of Greater Sudbury to Regulate the Keeping of Animals, Responsible Pet Ownership and of Registration of Dogs and Cats

Whereas Council of the City of Greater Sudbury wishes to amend By-law 2017-22 being a By-law of the City of Greater Sudbury to regulate the Keeping of Animals, Responsible Pet Ownership and of Registration of Dogs and Cats, as amended;

#### Now therefore Council of the City of Greater Sudbury hereby enacts as follows:

#### Replace Section 8

1. By-law 2017-22 being a By-law of the City of Greater Sudbury to regulate the Keeping of Animals, Responsible Pet Ownership and of Registration of Dogs and Cats, as amended, is hereby further amended by repealing section 8 and enacting the following section 8 in its place and stead:

#### "Application for License / Renewal of License

- **8.** Every applicant for a License or renewal of a License under this By-law shall file with or provide to the License Issuer:
  - (a) an application in the form established by the License Issuer from time to time:
  - (b) where applicable, evidence satisfactory to the License Issuer that the Dog or Cat has been Altered:
  - (c) where applicable, evidence satisfactory to the License Issuer that the Dog or Cat for which the License is applied is a Service Animal or a Police Work Dog;
  - (d) where a Dog has been found to be a vicious Dog:
    - (i) evidence of insurance compliant with section 31;
    - (ii) evidence the Dog is and continues to be Microchipped; and
    - (iii) a current photograph of the Dog adequate for identification purposes; and
  - (e) except as provided to the contrary in section 9, payment of the applicable Fee for applying for a License."

#### Replace Section 10

**2.** By-law 2017-22 being a By-law of the City of Greater Sudbury to regulate the Keeping of Animals, Responsible Pet Ownership and of Registration of Dogs and Cats, as amended, is

hereby further amended by repealing section 10 and enacting the following section 10 in its place and stead:

#### "Refusal to Issue License

- **10.** The License Issuer shall refuse to issue or renew a License for a Dog or Cat unless the License Issuer is not satisfied that:
  - (a) the applicant is 18 years or age or older;
  - (b) the application is complete;
  - (c) applicable Fees have been paid; and
  - (d) in the case of a Dog found to be a vicious Dog:
    - (i) the required insurance in accordance with section 31 is not in effect:
    - (ii) the Microchip information for the Dog is not current or the microchip is not functioning; or
    - (iii) a current photograph of the dog suitable for identification purposes has not been filed."

#### Replace subsection 11(2)

- **3.** By-law 2017-22 being a By-law of the City of Greater Sudbury to regulate the Keeping of Animals, Responsible Pet Ownership and of Registration of Dogs and Cats, as amended, is hereby further amended by repealing subsection 11(2) and enacting the follow subsection 11(2) and 11(3):
  - "11.-(2) Each Tag provided by the Licence Issuer pursuant to subsection 11(1) shall be in the form established by the License Issuer from time to time, and shall:
    - (a) bear a unique serial number;
    - (b) set out the year of expiry; and
    - (c) set out such other information as may be determined by the License Issuer.
    - (3) The Licence Issuer may establish a separate form of Tag to be used for a Dog found to be vicious Dog.
    - (4) A current Tag shall be evidence that that a License has issued for the Dog or Cat."

#### Repeal subsection 30(3) and Enact subsection 30(3) – 30(4)

- **4.** By-law 2017-22 being a By-law of the City of Greater Sudbury to regulate the Keeping of Animals, Responsible Pet Ownership and of Registration of Dogs and Cats, as amended, is hereby further amended by repealing subsection 30(3) and enacting the following subsections 30(3) and 30(4):
  - "(3) Unless provided to the contrary by the Hearing Committee, the Owner of a Dog found to be a vicious Dog shall within the time line in subsection 30(4):
    - (a) provide evidence to the License Issuer the vicious Dog has been microchipped;
    - (b) file with the License Issuer, a current photograph of the vicious Dog, for identification purposes, acceptable to the License Issuer;
    - surrender any Tag issued for that Dog for the year and obtain a replacement Tag from the License Issuer appropriate for a Dog found to be a vicious Dog; and
    - (d) pay the applicable fee for a Tag for a Dog found to be a vicious Dog,determined in accordance with the City's Miscellaneous User Fee By-law.
  - (4) The Owner of a Dog found to be a vicious Dog shall comply with subsection 30(3) within:
    - (a) 21 days of the effective date of service of the notice of the finding by the License Issuer that the Dog is a vicious Dog, in the event that no appeal is filed to the Hearing Committee; or
    - (b) the date on which the Hearing Committee confirms the finding that a Dog is a vicious Dog, in the event that an appeal is filed to the Hearing Committee."

#### Add Section 30A

- **5.** By-law 2017-22 being a By-law of the City of Greater Sudbury to regulate the Keeping of Animals, Responsible Pet Ownership and of Registration of Dogs and Cats, as amended, is hereby further amended by adding the following section 30A immediately after section 30 and before section 31:
  - "30A The Licence Issuer shall attend at the property where the owner of a Dog found to be a vicious dog resides to inspect for compliance with the requirement of Sections 29 and 30, as required, in the opinion of the Licence Issuer, and no less than annually."

#### Add Section 31A

**6.** By-law 2017-22 being a By-law of the City of Greater Sudbury to regulate the Keeping of Animals, Responsible Pet Ownership and of Registration of Dogs and Cats, as amended, is hereby further amended by adding the following section 31A immediately after section 31 and before section 32:

#### "Registry

- **31A**(1) The Licence Issuer shall maintain and keep current, a register of Dogs found to be a vicious Dog under this by-law, including:
  - (a) the identification number assigned to the Dog by the License Issuer;
  - (b) the ward in which the owner of the Dog resides;
  - (c) the first three digits of the postal code assigned to the property where the owner of the Dog resides;
  - (d) the name, breed and color of the Dog;
  - (e) the date and location of the incident which led to the determination of the Dog being found to be a vicious Dog; and
  - (f) such other information as the Licence Issuer deems necessary to protect the public.
- (2) The register shall be made available to the public in a form and in a manner determined by the License Issuer from time to time."
- 7. This By-law shall come into full force and effect upon passage.

  - (a) repealing Schedule "CS-7" Enforcement and enacting, in its place and stead, Schedule "CS-7" Enforcement attached hereto as Schedule "A" and forming part of this By-law;
  - (b) repealing Schedule "CS-8" Animal Care and Control and enacting, in its place and stead, Schedule "CS-8" – Animal Care and Control attached hereto as Schedule "B" and forming part of this By-law.
- 2. This By-law shall come into full force and effect upon passage.

#### A By-law of the City of Greater Sudbury to Amend By-law 2021-111 being a By-law of the City of Greater Sudbury to Regulate the Erection of Signs and Advertising Devices

**Whereas** Council for the City of Greater Sudbury wishes to amend By-law 2021-11 being a By-law of the City of Greater Sudbury to Regulate the Erection of Signs and Advertising Devices, as amended;

#### Now therefore Council of the City of Greater Sudbury hereby enacts as follows:

#### **Preamble**

1. By-law 2021-111 being a By-law of the City of Greater Sudbury to Regulate the Erection of Signs and Advertising Devices, as amended, is hereby further amended by deleting the word "sections" and replacing it with "section" and also deleting "and 99.1" in the third preamble of the By-law.

#### Part 1 – Terminology

- 2. By-law 2021-111 being a By-law of the City of Greater Sudbury to Regulate the Erection of Signs and Advertising Devices, as amended, is hereby further amended by amending Part 1 Terminology as follows:
  - (a) In the definition of Awning, by deleting "structure" and replacing it with "Structure";
  - (b) In the definition of Canopy, by adding the following after "structure" and before "projecting": "unenclosed by building walls";
  - (c) In the definition of Electronic Billboard Sign, by deleting "Billboard" after "a" and before "Sign" and replacing it with "Permanent";
  - (d) In the definition of Erect, by adding the following sentence after "relocate":"Erected, Erecting and Erection shall have the same meaning as Erect;";
  - (e) In the definition of Façade, by deleting "an" and replacing it with "a" and include the following after "parapet" and before the comma: "and any protrusion of walls along the building";
  - (f) Adding the following definition: "Fuel Station Canopy Sign" means a sign located on the canopy structure above the pump island;";
  - (g) In the definition of Illuminated, by adding "and Illuminate" after "Illumination" and before "has";
  - (h) Moving the definition of Lawn Bag Sign to after Information Sign;

- (i) In the definition of Information Sign, by adding "that is less than 0.5m² in size" after "Sign" and before "which";
- (j) In the definition Property, by adding the following sentence after "thereon": "Properties shall have the same meaning as Property;";
- (k) In the definition Sign Area, (b), by deleting "structure" and replacing it with "Structure"; and
- (I) In the definition Zone, by adding the following sentence after "By-law": "Zoned shall have the same meaning as Zone;".

#### Part 3 – Application of By-law & Exceptions

- 3. By-law 2021-111 being a By-law of the City of Greater Sudbury to Regulate the Erection of Signs and Advertising Devices, as amended, is hereby further amended by amending Part 3 Application of By-law & Exceptions as follows:
  - (a) In 5(1), by deleting "Property" and replacing it with "Properties"; and
  - (b) In 7(g), by deleting "erected" and replacing it with "Erected".

#### Part 4 – General Rules

- **4.** By-law 2021-111 being a By-law of the City of Greater Sudbury to Regulate the Erection of Signs and Advertising Devices, as amended, is hereby further amended by amending Part 4 General Rules as follows:
  - (a) In 15(1)(c), by deleting "illuminated" and replacing it with "Illuminate" and by deleting the comma after "horizontal"; and
  - (b) In 17(1)(f), by adding "Sign" after "Billboard" and before "or".

#### Part 5 – Sign Permits – Application / Issuance / Revocation, etc.

- **5.** By-law 2021-111 being a By-law of the City of Greater Sudbury to Regulate the Erection of Signs and Advertising Devices, as amended, is hereby further amended by amending Part 5, Sign Permits Application / Issuance / Revocation, etc. as follows:
  - (a) In 20(5)(b), by deleting the word "Manager" and replacing it with "Permit Issuer".

#### Part 6 – Permanent Signs

6. By-law 2021-111 being a By-law of the City of Greater Sudbury to Regulate the Erection of Signs and Advertising Devices, as amended, is hereby further amended by amending Part 6 – Permanent Signs as follows:

- a. In Table 2, by deleting the Footnote to Table 2 in its entirety and removing the references to it in "Additional Regulation";
- b. In Table 3, Parts 1 and 2, by:
  - Under Billboard Sign or Electronic Billboard Sign, by adding "C6" in the Zones Permitted section;
  - ii. Under Billboard Sign or Electronic Billboard Sign, Maximum Sign Area, by deleting "20.0m²" and replacing it with the following: "20.0m² if Ground Sign, If Wall Sign, See Maximum Sign Area of Wall Sign";
  - iii. Under Direction Sign, Maximum Sign Area, by deleting "0.3m²" and replacing it with "0.5m²"; and
  - iv. Under Wall Sign, Maximum Sign Height, by deleting "Lesser of 4.5 m or the base of windows on any story above the ground floor" and replacing it with "2.75 m minimum clearance above Grade".
- c. In Table 4, by:
  - i. Deleting the extra "&" in the table heading; and
  - ii. Adding Awning Sign and Canopy Sign regulations (found in Table 3) for M1-1 and M1 zones.
- d. In Table 5, by:
  - i. Under Wall Sign, Maximum Sign Height, by deleting "story" and replacing it with "Storey".
- e. In Table 6, by:
  - i. Deleting the footnote for Ground Sign and Wall Sign and replacing it with dashed line; and
  - ii. Deleting "Footnote to Table 6 1. Only permitted non-residential uses".
- f. In 41(f), by:
  - i. Deleting "or" at the end of (i) and deleting the period at the end of (ii) and replacing it with "; or"; and
  - ii. Adding the following provision: "(iii) 100.0 metres or more from lands Zoned for residential uses".
- g. In 42, by adding the following provision: "(f) the Electronic Message Board is Erected in a location which is not 100.0 metres or more from any other Electronic Message Board".
- h. In Fuel Price Sign, by:
  - i. Adding the following to the heading "and Fuel Station Canopy Sign";
  - ii. In 43, by adding a "-(1)" immediately after; and

- iii. In 43, by adding the following provision: "(2) Where an automotive service station of gas bar use is authorized within a Zone, an Illuminated Fuel Station Canopy Sign is permitted on all sides with a 2.75m minimum clearance above grade and no portion of the sign extending beyond the limits of the canopy face.".
- i. In 44(1), by adding "or" at the end of (c), removing "; or" at the end of (d) and replacing it with a period and deleting sentence (e).

#### Part 8 – Signs Within a Road Allowance

- 7. By-law 2021-111 being a By-law of the City of Greater Sudbury to Regulate the Erection of Signs and Advertising Devices, as amended, is hereby further amended by amending Part 8 Temporary Signs as follows:
  - (a) In 61(2), by deleting "Manager" and replacing it with "Permit Issuer".

#### Part 9 – Variances and Appeals

- 8. By-law 2021-111 being a By-law of the City of Greater Sudbury to Regulate the Erection of Signs and Advertising Devices, as amended, is hereby further amended by amending Part 9
  Signs Within a Road Allowance as follows:
  - (a) In 64(1), Sign Variance Committee, by deleting "Adjustments" and replacing it with "Adjustment";
  - (b) In 64(6), by correcting the alphabet order;
  - (c) In 64(10), by deleting "and" after (a) and before (b), and replacing it with "or"; and
  - (d) In 64(7), by deleting "and" after (a) and before (b), and replacing it with "or".
- 9x. This By-law shall come into full force and effect upon passage.

A By-law of the City of Greater Sudbury to Authorize an Agreement with Nickel District Conservation Authority for Provision of Non-Mandatory Programs and Services

Whereas pursuant to Ontario Regulation 686/21, conservation authorities and municipalities are required to enter into agreements with respect to non-mandatory services;

**And Whereas** the City of Greater Sudbury deems it desirable to obtain certain non-mandatory services from the Nickel District Conservation Authority and to fund such services, in whole or in part, through the tax levy;

**And Whereas** Council of the City of Greater deems it desirable to execute a Programs and Services Support Agreement with the Nickel District Conservation Authority with respect to certain non-mandatory services;

#### Now therefore Council of the City of Greater Sudbury hereby enacts as follows:

- 1. The General Manager of Growth and Infrastructure is hereby authorized on behalf of the City of Greater Sudbury to execute a Programs and Services Support Agreement with Nickel District Conservation Authority to acquire and pay for certain non-mandatory services and is further authorized to execute any amendments to the Agreement, any renewals or extensions of the Agreement and any documents required under the Agreement.
- **2.** By-law 2024-43 is hereby repealed.
- **3.** This By-law shall come into full force and effect upon passage.

**And Whereas** pursuant to Section 107 of the *Municipal Act 2001*, S.O. 2001 c. 25, Council may pass by-laws for grants to certain bodies for purposes in the interest of the municipality;

And Whereas Council of the City of Greater Sudbury wishes to approve the grants made to eligible event organizers in the 2023 calendar year through direct (cash contribution or sponsorship) or indirect (staff time, promotional material, meeting rooms and other assistance) support;

#### Now therefore Council of the City of Greater Sudbury hereby enacts as follows:

- 1. Council of the City of Greater Sudbury hereby approves for the 2023 calendar year, the grants to the event organizers identified in the first column, in the amount set out in the second column and in support of the Event described in the third column of the corresponding line all as set out on the chart found on Schedule "A" attached to and forming part of this By-law.
- **2.** This By-law shall come into full force and effect upon passage.

### A By-law of the City of Greater Sudbury to Authorize Grants Under the Strategic Core Areas Community Improvement Plan

Whereas Council of the City of Greater Sudbury adopted the Strategic Core Areas Community Improvement Plan pursuant to By-law 2022-128 to apply within the Strategic Core Areas designated by By-law 2022-127, and replacing both the Downtown Sudbury Community Improvement Plan and the Town Centres Community Improvement Plan;

**And whereas** the Strategic Core Areas Community Improvement Plan provides certain financial incentives;

And Whereas Council wishes to authorize the making of certain grants in accordance with the applicable guidelines for the financial incentives set out in the Strategic Core Areas Community Improvement Plan;

#### Now therefore Council of the City of Greater Sudbury hereby enacts as follows:

- 1.-(1) Council of the City of Greater Sudbury hereby authorizes by way of grant, financial incentives of the type described in Column C on the chart in Schedule "A", for the purpose described in Column B of the chart, in the amount specified in Column D in the chart, to the applicant and for the benefit of the property described in Column A in the chart. Each such grant shall be provided and administered in accordance with the applicable guidelines established in the Strategic Core Areas Community Improvement Plan adopted under By-law 2022-128, for that type of financial incentive, applicable within the geographic areas designated by By-law 2022-127.
- (2) Each grant referenced in subsection 1(1) is expressly conditional upon the grantee named in Schedule "A" having entered into an agreement with the City of Greater Sudbury setting out the terms of the Grant, no later than six (6) months of the date of passage of this Bylaw.
- 2. The General Manager, Growth and Infrastructure is hereby authorized to execute any agreement or other document necessary to set out the terms on which the grants identified in Schedule "A" will be provided and to execute any necessary amendments or extensions in accordance with the Strategic Core Areas Community Improvement Plan. The General Manager is further authorized to make all decisions, perform all functions required pursuant to the agreement in order to administer and implement the terms of the agreement.

- 3. The City Treasurer may advance all or part of the grant up to the maximum amount identified in Schedule "A" at such time or from time to time, to such person and in such amount as may be requested in writing by the General Manager of Growth and Infrastructure, confirmation the grantee has entered into the grant agreement in a timely manner, and all in accordance with the Strategic Core Areas Community Improvement Plan.
- **4.** Schedule "A" is incorporated into and forms a part of this By-law.
- **5.** This By-law shall come into full force and effect upon passage.

### A By-law of the City of Greater Sudbury to Amend By-law 2010-100Z being the Comprehensive Zoning By-law for the City of Greater Sudbury

Whereas Council of the City of Greater Sudbury deems it desirable to amend By-law 2010-100Z being the Zoning By-law for the City of Greater Sudbury;

#### Now therefore Council of the City of Greater Sudbury hereby enacts as follows:

**1.-**(1) That By-law 2010-100Z being the Zoning By-law for the City of Greater Sudbury, and Schedule "A" attached thereto, be and the same is hereby amended by changing the zoning classification of the following legally described lands from "RU(10)", Rural Special to "C3(28)", Limited General Commercial Special;

(2) Property Description: PIN 73377-0004 (LT)

Parcel 10840 SWS

Part of Lot 7, Concession 5 as in LT73031

and Part 2, Plan 53R-15349

Township of Waters. Greater Sudbury

2. That By-law 2010-100Z being the Zoning By-law for the City of Greater Sudbury be and the same is hereby amended by adding the following paragraph to Part 11, Section 2, Subsection (3):

### (bb) C3(28) (Candle manufacturing and *Food processing plant*) Waters Map 1; Waters Map 5

Notwithstanding any other provision hereof to the contrary, within any area zoned C3(28) on the *Zone Maps*, all provisions of this by-law applicable to the "C3", Limited General Commercial zone shall apply subject to the following modifications:

- (i) That an *industrial use*, being candle manufacturing, be permitted;
- (ii) That an *industrial use*, being candle manufacturing, have a gross floor area no greater than 50 metres squared (not counting accessory uses);
- (iii) That a *food processing plant*, being a *commercial* kitchen, be permitted; and,
- (iv) That a *food processing plant*, being a *commercial* kitchen, have a gross floor area no greater than 15 metres squared.
- 3. The applicant, a person or public body who, before the by-law was passed, made oral submissions at a public meeting or written submissions to the council, or the Minister may appeal the passage of this By-law to the Ontario Land Tribunal by filing with the City Clerk, within 20 days of the giving of notice of passage of the By-law by the City Clerk:

- (a) a Notice of Appeal;
- (b) an explanation of how the by-law is inconsistent with a policy statement issued under subsection 3(1) of the *Planning Act*, fails to conform with or conflicts with a provincial plan or fails to conform with an applicable official plan; and
- (c) the fee prescribed under the Ontario Land Tribunal Act, 2021.

If these materials and fees have not been filed with the City Clerk within this period, this By-law shall be deemed to have come into force on the day it was passed.




