#### **Report Summary**

This report requests that the City of Greater Sudbury confirm the citizen appointments to the Greater Sudbury Utilities and Greater Sudbury Hydro as recommended by the Nominating Committee of the GSU Board.

#### Resolution

THAT the City of Greater Sudbury appoints André Thibert and Ryan Dutrisac for a four-year term as Directors of Greater Sudbury Utilities Boards and that Joshua Lilley and Fern Dominelli be appointed for a four-year term as Directors of Greater Sudbury Hydro, all until their successors are appointed as outlined in the report entitled "Appointment of Citizens to GSU and GSH", from the General Manager of Corporate Services, presented at the City Council meeting on March 25, 2025.

# **Background**

As provided in the Shareholders Declaration By-law 2019-183, the GSU Board's Nominating Committee, consisting of the three Councillors appointed to the Board, evaluates and recommends potential candidates

for Private Directors to the two Boards of City Council. The Committee is expected to consider Section 4.2 when recommending candidates.

Section 4.2 reads as follows:

"Qualifications of Directors - In addition to sound judgment and personal integrity, the qualifications of candidates for the Board or the board of directors of any Subsidiary may include:

- (a) awareness of public policy issues related to the Corporation or a Subsidiary, as applicable.
- (b) business expertise (including retail experience).
- (c) experience on boards of commercial corporations.
- (d) financial, legal, engineering, IT, accounting and/or marketing experience.
- (e) regulated industry knowledge including, but not limited to, knowledge of municipal electric utilities; and
- (f) knowledge and experience with risk management strategy."

According to Section 4.6 of the Shareholder Declaration By-law 2019-183, the Council of the City of Greater Sudbury, as a Shareholder, shall consider candidates for the Board and Subsidiaries' Boards nominated by the Nominating Committee and assess the qualifications listed in Section 4.2.

The Nominating Committee of the Board reviewed the applications. It recommended (see attached) that André Thibert and Ryan Dutrisac be appointed for a four-year term as Directors of Greater Sudbury Utilities. Additionally, Joshua Lilley and Fern Dominelli be appointed for a four-year term as Directors of Greater Sudbury Hydro, respectively, until their successors are appointed.
