AND WHEREAS in the opinion of Council for the City of Greater Sudbury, the act of parking, standing or stopping a vehicle on a front yard, side yard or boulevard is or could become a public nuisance;

AND WHEREAS section 425 of the Municipal Act, 2001 establishes that any person who contravenes any by-law of the municipality is guilty of an offence;

AND WHEREAS section 439 of the Municipal Act, 2001 provides that the owner of a vehicle is guilty of an offence even if the owner is not the driver of the vehicle, where a vehicle has been left parked, stopped or standing in contravention of a by-law;

THEREFORE BE IT RESOLVED that the City of Greater Sudbury directs that staff present a by-law for Council's consideration that regulates parking in unauthorized areas, namely in front and side yards, except as otherwise permitted by the City's Zoning By-law, within the City of Greater Sudbury at the August 9, 2022 meeting of City Council.
