7.1 Request for Report Regarding Fire Route S

The following resolution was presented:

WHEREAS a Whitewater Lake Park roadway runs immediately adjacent to people's backyards on Parkview, and was never designed or intended as a public roadway;

AND WHEREAS the Ward Councillor has received numerous complaints from residents on Parkview regarding the dust, noise, and danger caused by speeding issues associated with this roadway in the park;

AND WHEREAS historically Fire Route S was accessed from a point approximately 350m further North along that park road;

THEREFORE BE IT RESOLVED that the City of Greater Sudbury directs that staff provide a report and recommendations regarding the status, ownership, and operation of the park road that runs South of Montée Principale off of Ste. Agnes, and connects through to the Northern gate of Whitewater Lake Park and the Fire Route S Waste Transfer Station, to be presented to the Operations Committee during the 2nd quarter of 2023;

AND BE IT FURTHER RESOLVED that the report consider public consultation, relocation of the park gate, the potential to restrict public access from this section of park road, and the relocation of the waste transfer station.
