# 4.1 Mechanical Ice Breaker for Sidewalk Winter Maintenance 2021-2022 Pilot Project Update

THAT the City of Greater Sudbury directs staff to include an incremental budget increase of \$14,000 to the 2023 operating budget, for a total permanent budget of \$40,000, for Operations staff to continue utilizing the

Mechanical Ice Breaker during the winter months to address sidewalk rutting issues on a case-by-case basis with an emphasis given to the busiest sidewalks in the City as outlined in the report, entitled "Mechanical Ice Breaker for Sidewalk Winter Maintenance 2021-2022 Pilot Project Update", from the General Manager of Growth and Infrastructure, presented at the Operations Committee meeting on July 11, 2022.

# 5.1 Request to Prohibit Left Hand Turns from Stonegate Drive to Beatrice Crescent

The following resolution was presented:

WHEREAS residents of Stonegate Drive experience a significant volume of speeding non-local traffic cutting through to get to the Adanac Ski Hill on Attlee Avenue, creating safety concerns;

AND WHEREAS cut through traffic could be deterred if left hand turns from Stonegate Drive to Beatrice Crescent were prohibited;

THEREFORE BE IT RESOLVED that the City of Greater Sudbury direct that left hand turns from Stonegate Drive to Beatrice Crescent be prohibited, and that staff prepare a by-law to amend Traffic and Parking By-law 2010-1 to implement the change and install the necessary signage to alert drivers.

# 5.2 Request for Information Report Regarding Roadway Separation for Notre Dame St., Azilda

WHEREAS the residents of Azilda have presented a second petition to Greater Sudbury City Council calling for sidewalks along Notre Dame Street in Azilda:

AND WHEREAS the City's Complete Streets Policy adopted in 2018 reads "The City of Greater Sudbury shall plan, design, construct, operate, and maintain the transportation network to provide a comprehensive and integrated network of facilities that are safe and convenient for people of all ages and abilities travelling by foot, bicycle, public transit or vehicle";

AND WHEREAS an Active Transportation Town hall meeting in Azilda identified a need for physical separation between the people walking or biking and motorized vehicle traffic for residents to feel comfortable and safe:

THEREFORE BE IT RESOLVED that the City of Greater Sudbury directs staff to prepare a report that provides information on how active transportation facilities that include year-round physical separation from the roadway can be incorporated into future investments into Notre Dame St in Azilda, to be presented to the Operations Committee in Q2 2023.

# 5.3 Request for Business Case for 2023 Budget for Speed Hump on Attlee Avenue

The following resolution was presented:

WHEREAS traffic calming measures in the form of speed humps were initiated on the section of Attlee Avenue closest to Lasalle Blvd;

AND WHEREAS traffic volumes and speeding continue to be a concern on Attlee Avenue near Beatrice Crescent due in part to vehicles heading to the Adanac Ski Hill and Rotary Park trail system;

AND WHEREAS the addition of a speed hump on Attlee Avenue between Lexington Court and Beatrice Crescent would be a deterrent to increased traffic volumes and speeds in this area;

THEREFORE BE IT RESOLVED that the City of Greater Sudbury directs staff to present a business case for Council's consideration during the 2023 budget deliberations for the addition of a speed hump on Attlee Avenue between Lexington Court and Beatrice Crescent.
