Part B, the Amendment, which consists of the following map entitled Schedule "A", constitutes Amendment 130 to the City of Greater Sudbury Official Plan.

PART A - THE PREAMBLE

Purpose of the Amendment:

The proposed amendment is a site-specific application to provide a site-specific exemption to the policies in Section 4.2.1 Downtown, specifically Policy 1 which lists permitted uses.

Location:

PINs 02138-0196(LT) & 02138-0159(LT), Part Unit 1 on Plan D-132 being Part 5 on Plan 53R-17387, Units 3-10, 14 & 20-22 on Plan D-132 except Parts 2 & 3 on Plan 53R-17387, Unit 16 & Part Units 13 & 15 on Plan D-132 being Parts 1, 3 & 4 on Plan 53R-5227, Parts 1-5, Plan SR-3534, Part 2, Plan 53R-17475, Part Lot 5, Concession 4, Township of McKim, Sudbury (40 Elm Street, Sudbury)

Basis:

An Application for Official Plan Amendment (File #701-6/24-05) has been submitted for consideration by Planning Committee and Council in order to provide a site-specific exemption to the policies in Section 4.2.1 Downtown, specifically Policy 1 which lists permitted uses and does not include industrial use. The application, together with a concurrent Application for Zoning By-Law Amendment (File #751-6/24-08), would facilitate the development of warehouse and commercial self-storage facility uses within the existing Elm Place Shopping Centre, which are considered industrial uses.

PART B - THE AMENDMENT

1) By adding to Part 21, Site Specific Policies the following Section:

21.XXX Notwithstanding anything to the contrary on lands

0159(LT), Part Unit 1 on Plan D-132 being Part 5 on Plan 53R-17387, Units 3-10, 14 & 20-22 on Plan D-

132 except Parts 2 & 3 on Plan 53R-17387, Unit 16 & Part Units 13 & 15 on Plan D-132 being Parts 1, 3 & 4 on Plan 53R-5227, Parts 1-5, Plan SR-3534, Part 2, Plan 53R-17475, Part Lot 5, Concession 4, Township of McKim, Sudbury, warehouse and commercial self-storage facility uses shall be permitted.

2) Schedule 2c Site Specific Policies of the Official Plan for the City of Greater Sudbury is hereby amended by adding a site-specific policy 21.XXX on PINs 02138-0196(LT) & 02138-0159(LT), Part Unit 1 on Plan D-132 being Part 5 on Plan 53R-17387, Units 3-10, 14 & 20-22 on Plan D-132 except Parts 2 & 3 on Plan 53R-17387, Unit 16 & Part Units 13 & 15 on Plan D-132 being Parts 1, 3 & 4 on Plan 53R-5227, Parts 1-5, Plan SR-3534, Part 2, Plan 53R-17475, Part Lot 5, Concession 4, Township of McKim, Sudbury, as shown on Schedule "A" attached to this amendment.
