Fleet Section

The Fleet Section received two Ford pickup trucks. One assigned to the Platoon Chiefs who works out of Main Station and the other will be a Support Unit at the Capreol Station. Fleet also took delivery of a new Tanker built by Dependable Emergency Vehicles. This truck has been assigned to Dowling Station. The retired tanker has been reassigned as a spare or Reserve Tanker.

The 2003 American LaFrance Platform Ladder Truck was sent to Dependable Emergency Trucks for an assessment on the aerial device. After inspection and testing, it was determined that the repairs would be too costly. The truck will be assigned to the Training Division and used strictly on the training grounds as a

training aid for Pump Operations. We are procuring a new aerial platform with an expected delivery date in 2028.

NFPA hydrostatic testing on all self-contained breathing apparatus cylinders is ongoing. This testing is an annual requirement to ensure the safe operation of our breathing apparatus.

Structural concerns were brought to the City's Building and Assets Section regarding the Fire Training Tower at the Lionel E Lalonde Centre. Structural assessments have been conducted by A2S Consulting Engineers and Labbs Industries and a plan is being developed for required repairs of the training tower.

Fire Prevention

The Fire Prevention and Public Education Sections include a Chief Fire Prevention Officer, five Fire Prevention Officers, a Public Safety Officer, and a Fire Prevention Clerk. Guided by the Office of the Fire Marshal (OFM), our efforts focus on two lines of defense: Public Fire Safety Education and Fire Safety Standards and Code Enforcement.

Fire Prevention conducted:

- To date, Fire Prevention staff have conducted 222 occupancy inspections resulting from complaints, requests, and routine inquiries.
- Inspectors are in the final stages of completing mandatory inspections of our 54 care facilities. These will be completed by the end of November and registered with the Ontario Fire Marshall's office.
- The routine inspection program is completing the first of three years to inspect seven plus multi-family units in the City.
- The plans examiner has been following new construction projects, site plans, and on-site occupancy inspections.
- 31 on-site inspections have occurred for occupancy permits since August.
- 32 new plan reviews, and numerous site plan reviews/meetings for new construction.

Public Education

The City of Greater Sudbury Fire Services (GSFS) delivers life-saving messages through various fire safety education programs and activities. These programs focus on addressing specific fire risks and collaborate with community groups to enhance public fire safety education.

- August-December consisted of multiple events including New Sudbury and Valley Days and community events for outside organizations.
- Our team completed multiple presentations including information sessions for international students before the school year, Fire Prevention Week, Carbon Monoxide Week, and the Fire Safe Holidays Campaign.
- New commercials, radio messages, and content on social media have been recorded to deliver safety messages to the community.
- The "Safe and Sound" Smoke Alarm Program is ready to kickstart with the door-to-door program.

Training Section

Fire Services delivers high-quality training programs to both the volunteer and full-time suppression staff. Our training ensures that new recruits and existing firefighters meet the Ontario Fire Marshal regulatory standards to deliver the Council approved service levels. The introduction of the Ontario Fire Marshal's mandatory certification has required our fire service to significantly increase our training requirements, and our firefighters' recent success in certification exams highlights the quality and effectiveness of our programs.

Volunteer Firefighter Training

A Volunteer Recruitment and Certification Update report is on the December 10, 2024 City Council meeting agenda.

Career Firefighter Training

- The training section completed career recruitment in September 2024, which involved a ten-week training academy attended by 11 new recruits.
 - Candidates completed Certification in Firefighter 1001 Level I & II as well as Hazardous Materials NFPA 1072 Awareness/Operations Mission Specific.
- Blue Card Command Training for Platoon Chiefs, Captains, & Acting Captains has been completed.
 - Continuing education is now being developed to maintain/develop skill set.
- Hazardous Materials Responders Station 3 & 16 have completed on-duty training to the Technician Level. Currently written and practical certification testing is being completed.
- A large undertaking this year was the reintroduction of mandatory training for Career Firefighters. This included the following training focus:
 - 2–10-hour days of Fireground Survival Skills, Rapid Intervention Crew Training, and live fire evolutions.
 - 2–10-hour days of Discipline specific training. i.e., Water Rescue, Hazardous Materials, Rope Rescue.
- Career Suppression staff without Firefighter 1001 Level I & II certification have completed required learning and achieved certification by completed knowledge and skills testing.
- 15 career staff have achieved the rank of Training Officer (able to support training on an as-neededbasis), completed in-house training officer testing, and achieved NFPA 1041 Fire Instructor I certification.
