

## **By-law 2015-37**

### **A By-law of the City Of Greater Sudbury to Authorize the Payment of Grants to Various Non-Profit Community Organizations in the Leisure Services Sector**

**Whereas**, pursuant to Section 107 of the *Municipal Act, 2001*, S.O. 2001, c. 25, Council may pass By-laws for grants to certain bodies for purposes in the interest of the City;

**And Whereas** the Council of the City of Greater Sudbury, as part of its budget deliberations approved certain grant allocations to certain non-profit community groups as being in the public interest;

**And Whereas** the 2015 budget was approved by Council of the City of Greater Sudbury;

**And Whereas** the Council of the City of Greater Sudbury wishes to make such grants;

**Now therefore the Council of the City of Greater Sudbury hereby enacts as follows:**


1. Council of the City of Greater Sudbury hereby grants to the non-profit community organizations specified in Column A, on Schedule "A" attached hereto and forming a part of this By-law, the sum set out in the corresponding row in Column B, for the purposes set out in the corresponding row in Column C for the 2015 calendar year.
2. Council for the City of Greater Sudbury authorizes a grant to Child Care Resources by way of:
  - (a) the use of the Gatchell Pool during the summer of 2015 for its summer programming, at no charge;
  - (b) advertising for its 2015 summer programming in the City's Leisure Guide at no charge; and
  - (c) assistance by City Staff in 2015 program registration at no charge.
3. Council of the City of Greater Sudbury hereby authorizes a grant to the Ukrainian Seniors' Centre, the holder of the Canadian Garlic Festival by way of supply and installation of signs and fencing required to close the northbound lanes of Notre Dame Avenue between Elm Street and Ste. Anne Street, Sudbury, in order to facilitate the holding of the Canadian Garlic Festival, to a value of \$2,000 as a grant in the 2015 calendar year.


4. The City's General Manager of Community Development is hereby authorized to execute any agreements, amendments thereto and other documentation necessary to set out the terms on which any one or more of the grants will be provided.

5. The City's Chief Financial Officer / Treasurer may advance all or part of each of the grants authorized herein at such time or from time to time, as may be requested in writing by the City's General Manager of Community Development.

6. This By-law shall come into full force and effect upon passage.
