

By-law 2015-11

**A By-Law of the City of Greater Sudbury to Authorize Transit Grants
for the 2014 Calendar Year**

Whereas the Council of the City of Greater Sudbury allocated certain funds in the year 2014 for the making of grants to provide transit assistance by way of support in kind in the form of complimentary transit tickets and passes and complimentary charter services for local not for profit organizations;


And Whereas pursuant to Section 107 of the *Municipal Act 2001*, S.O. 2001 c. 25, Council may pass by-laws for grants to certain bodies for purposes in the interest of the municipality;

And Whereas Council of the City of Greater Sudbury wishes to approve the grants made to non-profit organizations in the 2014 calendar year through provision of transit tickets or passes or the provision of charter services;


Now Therefore the Council of the City of Greater Sudbury hereby enacts as follows:

1. Council of the City of Greater Sudbury hereby approves for the 2014 calendar year, the grant to the non-profit organizations identified in Column A, of the transit tickets, passes or charter services described in Column B and to the value set out in Column C of the corresponding line all as set out on the chart found on Schedule "A" attached to and forming part of this By-law.
2. This By-law shall come into force and take effect upon final passage.
