

**By-law 2015-15**


**A By-Law of the City of Greater Sudbury to Appoint Municipal Enforcement Officers to Enforce the Public and Private Property Sections, the Disabled Parking Sections and the Fire Routes Sections of By-Law 2010-1**


**Whereas** the Council of the City of Greater Sudbury wishes to appoint Municipal Law Enforcement Officers to enforce the Public and Private Property Parking Sections, the Off-Street Parking for Disabled Persons Sections and the Fire Route Sections of By-law 2010-1;

**Now therefore the Council of the City of Greater Sudbury hereby enacts as follows:**

1. The persons named in Schedule "A" attached hereto, which Schedule shall form part of this By-law, are hereby appointed as Municipal Law Enforcement Officers who shall be named Parking Control Officers for the City of Greater Sudbury to enforce:
  - (a) Sections 34, 39 and 40 of the Traffic and Parking By-law 2010-1; and
  - (b) Sections 46 to 48 inclusive of the Traffic and Parking By-law 2010-1 for the locations specified.
2. The Clerk of the City of Greater Sudbury shall issue a Certificate of Appointment bearing his or her signature or facsimile thereof to the Municipal Law Enforcement Officers appointed by this By-law.
3. By-law 2014-264T is hereby repealed.
4. This By-law shall come into effect and take force immediately upon final passage.
