

## **By-law 2019-191**

### **A By-Law of the City of Greater Sudbury to Appoint Members to the Downtown Sudbury Board of Management for Central Business District Improvement Area**

**Whereas** pursuant to Subsection 204 of the *Municipal Act*, 201, S.O. 221, Council of the City of Greater Sudbury has authority to appoint members to the Board of Management for an area designated as a business improvement area;

**And Whereas** Chapter 32 of the Municipal Code for the former City of Sudbury, as amended, established a Central Business Improvement Area with a board of management now known as Downtown Sudbury;

**And Whereas**, in accordance with Chapter 32 of the Municipal Code for the former City of Sudbury, as amended by By-law 2010-229 of the City of Greater Sudbury, Council has the right to appoint to the Downtown Sudbury Board of Management, up to 2 Direct Council Appointees and 9 Non-Direct Council Appointees, being persons who are not councillors and who have been recommended to Council of the City of Greater Sudbury by the membership of the Business Improvement Area in accordance with the said By-law;

**And Whereas** such appointments were approved by resolution 2019-14 as to the Direct Council Appointees and by resolution 2019-36 as to the Non-Direct Council Appointees;

**And Whereas** one of the Non-Direct Council Appointees has resigned and in accordance with section 32.4.30, the Downtown Sudbury Board of Management has passed a resolution recommending to Council for the City of Sudbury the name of a person to be appointed in the place and stead of the Non-Direct Council Appointee who resigned;

**And Whereas**, Council for the City of Greater Sudbury deems it appropriate to pass a by-law appointing or confirming the members of the Downtown Sudbury Board of Management;

**Now therefore the Council of the City of Greater Sudbury hereby enacts as follows:**

1. The following nine persons are appointed or confirmed as Non-Direct Council Appointees to the Downtown Sudbury Board of Management for Central Business District Improvement Area for the term ending November 30th, 2022 or until such time as their successors are appointed:

1. John Arnold;


2. Bobbi Deisinger;

6. Rob Jones;
7. Julie Seguin;
8. Al Vardy; and
9. Wendy Watson.


