**A By-law of the City of Greater Sudbury to Amend
By-law 2019-52 being a By-law of the City of Greater Sudbury to
Appoint Councillors to Certain Boards and Corporations**


Whereas by By-law 2019-52 Council for the City of Greater Sudbury appointed Councillors to certain boards and corporations as set out therein for a term ending November 14th, 200 or until their successors are appointed;

And Whereas certain Councillors appointed under By-law 2019-52 to the Board of Directors for City of Greater Sudbury Community Development Corporation as provided for in By-law 2019-52 have resigned and Council has determined to appoint alternate Councillors to fill the vacancies created by the resignations and to amend By-law 2019-52 to reflect the resignations and new appointments;


Now therefore Council of the City of Greater Sudbury hereby enacts as follows:

1. By-law 2019-52 being a By-law of the City of Greater to Appoint Councillors to Certain Boards and Corporations, is hereby amended by repealing Schedule "A" and enacting, in its place and stead, Schedule "A", attached hereto as Schedule "A" and forming a part of this By-law
