

Health Impact Assessment (HIA)

"a combination of **procedures**, **methods and tools** by which a policy, a program or project may be judged as to its **potential effects** on the health of a population and the **distribution of effects** within the population" (Gothenburg Consensus Paper, 1999)



Why do a Health Impact Assessment?



Because you are proposing a new policy, program, or project that is NOT specifically intended to impact health and . . .



Because you want to know . . .


- 1. What are the potential health impacts of this policy/program?
- Will some members of our community be more impacted (positively or negatively) than others?



And because you want to know . . .

How can we minimize the negative and enhance the positive aspects of this policy to have the best impact on health?





HIA typically involves five steps

The scope and intensity of each of the steps is flexible and adaptable

Application of HIA in other municipalities

- Toronto Public Health <u>HIA framework</u>, 2008
- Peel public health impacts of <u>land use</u> planning, 2009
- Across municipal and county councils in the UK, Australia . . . "The key message from our local case studies is that HIA is do-able."

Pilot projects to explore use of HIA in a Canadian municipality



Sudbury & District <u>Health Unit</u> Service de santé publique

The Montérégie HIA Pilots:

- Highlighted issues not taken into account at the start of projects
- Prepared the municipality for citizen responses to projects
- Were "politically sound" demonstrated municipality's attentions to the health value of policies and projects
- Added value to policy or project development process

What can HIA do for the City of Greater Sudbury?





- Identifying *positive* health impacts can boost citizen support of CGS projects and policy decisions
- Identifying *potentially negative* health impacts *before* a project goes forward can save time and money in the long run
- HIA processes can promote communication and understanding across CGS departments and with community citizens
