By-law 2019-127

A By-law of the City of Greater Sudbury to Authorize Certain Grants for the Transportation Demand Management Community Grant Program

Whereas pursuant to Section 107 of the *Municipal Act, 2001*, S.O. 2001, c. 25 Council may pass by-laws for grants to certain bodies for purposes in the interest of the City;

And Whereas Council of the City of Greater Sudbury has authorized the use of part of the approved budget allocation to the Transportation Demand Management (TDM) Community Grant Program for the making of grants to non-profit eligible organizations to assist with community-based activities that have a positive city-wide impact and support implementation of the TDM Plan for Greater Sudbury;

And Whereas Council for the City of Greater Sudbury has determined that the initiatives as described in certain applications by non-profit organizations for funding under the 2019 "Transportation Demand Management (TDM) Community Grant Program" will have a positive city-wide impact and support the implementation of the Transportation Demand Management Community Grant Program;

And Whereas Council of the City of Greater Sudbury has determined it is in the public interest to make grants to such non-profit organizations with the approved initiatives:

Now therefore Council of the City of Greater Sudbury hereby enacts as follows:

1. Council of the City of Greater Sudbury hereby authorizes the making of a grant up to the amount specified in Column B of Schedule "A" attached hereto to the non-profit organization identified in Column A of the corresponding row in Schedule "A", to be used by each named grantee in the 2019 calendar year, for the purposes as set out in Column C of Schedule "A" and in accordance with the approved application submitted by each grantee.

2. The General Manager of Growth and Infrastructure is hereby authorized to execute any agreement, amendment or other related documents necessary to set out the terms on which the grant will be provided.

3. The Treasurer may advance all or part of the grant at such time or from time to time, as may be requested in writing by the General Manager of Growth and Infrastructure.

4. Schedule "A" is incorporated into and forms a part of this By-law.

5. This By-law shall come into full force and effect upon passage.
