Dear Mayor Rodriguez and Councillor Barbeau,

I am writing this letter concerning the City Transit schedule going to Lively. I am a grade eleven student living in Lively who attends Lockerby Composite School. I use the bus to go to and from school every day and I wish there could be more bus service to Lively. I would like to do extracurricular activities after school and go out on weekends but the bus schedules put a limit on what I can do. My parents have discussed this with many of their friends and family in Lively. Many of them would like to use City Transit (especially when gas was \$1.40!) but they would have to see an increase in the frequency of service to Lively. My friends and I all take City Transit on a regular basis and find the system difficult. The Lively bus is extremely packed at times and it won't wait for you if you're coming off a transfer that arrives at the exact time that the Lively bus leaves. The drivers won't hold the bus for you and then you have to wait another two hours for the next bus.

I don't understand why we have so few buses running to Lively compared to other outlying areas. I looked at the bus schedules for other areas and looked up population by area on the City of Greater Sudbury Keyfacts website. Of all the outlying areas, Lively has the least frequent bus service even though the population is not necessarily the lowest. I think it is unfair that Coniston has 12 bus trips a day while Lively only has 10, yet Lively has double the population!

This is the data I recorded:

Coniston/Wahnapitae - Population 3,400 - Daily Bus Departures 12 trips Garson/Falconbridge - Population 6,800 - Daily Bus Departures 13 trips Lively - Population 7,000 - Daily Bus Departures 10 trips Azilda/Chelmsford - Population 11,400 - Daily Bus Departures 14 trips

I would ask that you please run the Lively bus more frequently! This would mean the world to me if the bus ran every hour instead of two hours, even if this were just to happen in the early morning (to help working people) and in the afternoon (to help working students) I guarantee you that students, adults working, and everyone would greatly appreciate this. If you can't make it hourly, I have a couple of suggestions.

- 1) Add an extra route in the morning (around 7:45) from downtown to help people who live in Sudbury and work in Lively!
- 2) Add an extra route from Lively to downtown at 3:30 to help out the students who work in Sudbury to get to their jobs!

I am thankful that the Lively bus runs until 12:30 at night and runs more often on the

Sunday schedule. This is very convenient and I'd just like to point that out.

I would like to express one last concern. I was wondering why other municipalities, even Toronto, have a student fare but Greater Sudbury does not? I am happy that there is a Senior fare but I think that students deserve a reduced fare as well. We are in school, only work part-time and for some of us City Transit is our only means of transportation to school, work and even to fun!

Being a student and having to use City transit as my main method of transportation, I would be very grateful if you would consider the changes I've mentioned.

We had a meeting yesterday regarding the New Family Health Clinic in Walden. At present we are finalizing the parking area and vehicle entrances to this site and have a couple of items we need to address which you might be able to help us with.

The first is a need to identify if we are going to be able to have the bus route extended to allow a transit route to drop people at the Family Health Clinic on Black Lake Rd. This is critical as many of those accessing the site will be families with small children, people with existing health concerns and elderly patients. The distance from the existing bus stop on RR 55 to the site is far enough to pose a challenge for all of the above groups which to some extent would be alleviated by a bus stop at the site.

Given the above the second question would be what is the required turning radius for a transit bus so that we can assure ease of entry and departure should the route be extended to include the clinic. We are considering a couple of options should the route be extended and need some guidance in this area. From what we know of the area it might be difficult to use any of the local streets for this purpose. If you are familiar with the area you may have some other suggestions. Thanks Roger we need finalize this for funding purposes so if you could get back to us that would be appreciated.
