"Artuit" means a person 18 years of age or older other than a Student, a Senior or a Disability Pensioner

"Adult" means a person 18 years of age or older other than a Student, a Senior or a Disability Pensioner "Affordable Pass" means a person that qualifies for the Affordable Transit Pass program, administered through the Social Services department. Passes are limited and sold on a first come, first serve basis. "Annual Pass" means a current and valid Annual Pass issued by the City of Sudbury to a Disability Pensioner "Child" means a person who is 5 years of age or older and who is no talter than 60 inches "Concession" means pesses consist of reduced fares. Proper proof of eligibility must be presented.

Transfer Policy - Effective July 1, 2019 Transfers are available with Cash and Ride Card payment upon request and times are extended to 90 minutes, andcan be used in any direction. Support Parson Assistance - Effective July 1, 2019

Support Person Assistant card is available to persons who require assistance while traveling on Conventional Services through an application process. The Card belongs to the cardholder and permits one support person to travel with them free of charge.

Note: Free bus service is provided from 10:30 PM on New Year's Eve to 3:30 AM on New Year's Day Special cash fare of \$1.00 per person, applicable for shuttle bus service on Canada Day only.

*The definition of Employer Pass Bulk Purchases prior to July 1, 2019:

¹The definition of Employer Pass Bulk Purchases prior to July 1, 2019: Employer Pass Bulk Purchases: A Concessioned Adult 31 day pass based on a bulk purchase from one employer (minimum commitment of 6 consecutive months). Concessions are per pass using the following scale (based on volume of passes purchased): 50.99 = 5% (or \$4.60); 100.199 = 10% (or \$9.00); 200-299 = 15% (or \$13.50); 300-499 = 20% (or \$18.00); 500+ = 30% (or \$27.00)
