

MILESTONE

District Home for the Aged per legislative requirement for 121 beds. Managed by a Board of Directors

MILESTONE

Transfer of ownership to the Regional Municipality of Sudbury. Growth to 342 beds. Managed by a Regional Council

MILESTONE

Amalgamation – change in ownership and reporting to the City of Greater Sudbury, managed by a Committee of Management

MILESTONE

Terrace opens – moved residents from D classification beds to A beds

MILESTONE

Lodge opens increased by 64 permanent longterm care beds



Governance

Role of the Committee

- Duties to oversee the compliance of the licensee (the City) and exists independent from Council. (s. 69(2))
- Exercise the care, diligence and skill that a reasonable prudent person would exercise in comparable circumstances AND
- Take such measures as necessary to ensure that the City, as licensee, complies with all requirements under the LTCHA (s. 69(2))
- Duty to Report Matters to Director/Ministry (s. 24)
 - Improper or incompetent treatment or care of a resident
 - Abuse or neglect of a resident, unlawful conduct
 - Misuse or misappropriation of a resident's money or funding
- Whistle-blowing Protections (s. 26(1))
- Compliance Oversight Inspection Orders
- Quality Improvement Plans
