

**By-law 2020-139**

**A By-law of the City of Greater Sudbury to Amend Chapter 32  
of the Municipal Code of the Former City of Sudbury  
Regarding the Board of Management for the  
Downtown Sudbury Business Improvement Area**

**Whereas** subsection 5(3) of the *Municipal Act, 2001* provides that a municipal power shall be exercised by by-law;

**And Whereas** subsection 10(2) of the *Municipal Act, 2001* provides that a municipality may pass by-laws respecting the governance structure of the municipality and its local boards and the accountability and transparency of its local boards and their operations;

**And Whereas** the former Corporation of the City of Sudbury by By-law 76-24 designated the Central Business District as an Improvement area under s. 361 of the *Municipal Act*, R.S.O. 1970, c. 284, and by By-law 77-76 created a Board of Management for the Improvement Area for the Central Business District of the City of Sudbury;

**And Whereas** the former Corporation of the City of Sudbury passed By-law 91-12 adopting a Municipal Code which incorporated By-law 77-76 as amended as chapter 32;

**And Whereas** the Municipal Code permits amendments to be made to a chapter of the Municipal Code;

**And Whereas** chapter 32 of the Municipal Code has been amended from time to time;

**And Whereas** the Board of Management created initially under By-law 77-76 is now known as the Downtown Sudbury Board of Management;

**And Whereas** Council for the City of Greater Sudbury has determined it is in order to impose certain reporting requirements on the Downtown Sudbury Board of Management for the central business district for increased transparency of the activities of the said Board;

**Now therefore Council of the City of Greater Sudbury hereby enacts as follows:**

**Enact 32.5.10**

1. Chapter 32 of the Municipal Code of the former City of Sudbury, as amended, is further amended by enacting the following subsection 32.5.10 immediately after 32.5.9 and before 32.6.1:

"32.5.10 The Board shall report annually to Council for the City of Greater Sudbury on the Board's activities. The report shall take the form of a presentation to the Council and shall include without limitation:

- (a) a detailed review of the activities undertaken by the Board during the previous year;
- (b) a detailed review of the Board's proposed activities for the coming year;
- (c) an explanation of how the activities of the Board, both over the past year and planned for the future year, align with and advance, Council's Strategic Priorities and Annual Work Plan, as outlined in the report entitled "Overview and Recommendations in Relation to the City's Business Improvement Areas" from the General Manager of Corporate Services presented at the City Council meeting on June 2, 2020; and
- (d) an identification of those past activities of the Board which required City resources to support and implement and those proposed activities which the Board expects will require City resources to support and implement."

**Enact 32.6.6.1**


2. Chapter 32 of the Municipal Code of the former City of Sudbury, as amended, is further amended by enacting the following subsection 32.6.6.1 immediately after 32.6.6 and before 32.6.7:


"32.6.6.1 The Board shall submit with its current estimates for that year as required pursuant to subsection 32.6.6, a listing of the activities of the Board proposed for the year to which the estimates apply, that require City resources to support and implement."

**Effective**

3. This By-law shall come into full force and effect upon passage.
