## By-law 2020-131Z

A By-law of the City of Greater Sudbury to Amend By-law 2010-100Z Being the Comprehensive Zoning By-law for the City of Greater Sudbury

Whereas Council of the City of Greater Sudbury deems it desirable to amend By-law 2010-100Z being the Zoning By-law for the City of Greater Sudbury;

## Now therefore Council of the City of Greater Sudbury hereby enacts as follows:

- 1.-(1) That By-law 2010-100Z being the Zoning By-law for the City of Greater Sudbury, Schedule "A" attached thereto, be and the same is hereby amended by changing the zoning classification of the following lands from "M1(5)", Mixed Light Industrial/Service Commercial Special and "OSP", Open Space Private to a revised "M1(5)", Mixed Light Industrial/Service Commercial Special.
  - (2) Property Description: PIN 73496-0074 (LT) (formerly Part of PINs 73496-0449 & 73496-0447)

Parts 1, 2 & 4, Plan 53R-16246 and Part 3, 53R-21243

Part PIN 73496-0049(LT) Part 1 & 2, Plan 53R-21243

Part of Lots 8 & 9, Concession 1 Township of Garson, City of Greater Sudbury

- 2. That Part 11, Section 3, Subsection (1), Paragraph (e) pertaining to the M1(5) special zoning be revised by adding the following as Clause ii):
  - (ii) The minimum front yard setback shall be 9 metres.
- 3. The applicant, a person or public body who, before the by-law was passed, made oral submissions at a public meeting or written submissions to the council, or the Minister may appeal the passage of this By-law to the Local Planning Appeal Tribunal by filing with the City Clerk, within 20 days of the giving of notice of passage of the By-law by the City Clerk:
  - (a) a Notice of Appeal;
  - (b) an explanation of how the by-law is inconsistent with a policy statement issued under subsection 3(1) of the *Planning Act*, fails to conform with or conflicts with a provincial plan or fails to conform with an applicable official plan; and
  - (c) the fee prescribed under the Local Planning Appeal Tribunal Act, 2017.

If these materials and fees have not been filed with the City Clerk within this period, this By-law shall be deemed to have come into force on the day it was passed.

If these materials have been received within that time, this By-law shall not come into force until all appeals have been withdrawn or finally disposed of and except for those parts repealed or amended, and in such case it shall be deemed to have come into force on the day it was passed.

**4.** This By-law is in conformity with the City of Greater Sudbury Official Plan as amended by Official Plan Amendment #100.
