Question Period and Announcements

Review of Winter Maintenance for Atlee Avenue

Councillor Landry-Altmann asked that the winter maintenance for Atlee Avenue be reviewed.

Tony DaSilva, Roads Operations Engineer, advised that Atlee Avenue north of Lasalle is a Class 4-6 road which is plowed and sanded. If it is re-classed to class 3 and there is snow accumulation of five (5) centimetre, it is plowed and salted, based on temperature, every 8 hours. The current class is four (4) which is plowed and sanded every 24 hours. The policy to change the classification of this road would be a unique request and they would have to consider all streets.

Councillor Landry-Altmann said that Atlee Avenue has a very steep slope.

Tony DaSilva, Roads Operations Engineer, advised that the classification of roads is set by the *Municipal Act* and is based on the volume of traffic and speed of the road and does not take into consideration the geometry of the road.

Municipal Road 35 Culvert Plans

Councillor Dutrisac asked what the plans are for the culverts and repaving on Municipal Road 35.

Stephen Holmes, Director of Infrastructure Capital Planning, stated that the consultant engineer is working on the design and they will be tendering the culvert replacement and watermain work by late summer.

Holes on Lasalle Extension

Councillor Dutrisac asked if there are any plans to fill the holes on the Lasalle Extension, especially by the ramp area.

Stephen Holmes, Director of Infrastructure Capital Planning advised that the ramp is on the mill and pave list for this year and he will review the pothole situation.

Street Sweeping Issues

Councillor Vagnini expressed his concern with street sweeping not clearing around parked cars and sand being placed in residents front yards.

Tony DaSilva, Roads Operations Engineer, advised that there is no change in the street sweeping policy. He stated that there are areas, such as Copper Cliff, that are still being completed. The sand is heavy this year, resulting in multiple passes by the machines. In some areas where there are no curves, the policy is to push the sand to the edge of the shoulder. The sand falls into the ditch and is picked up when they complete ditching and shoulder work.

Handicap Parking Spot on Jacobson Drive

Councillor Vagnini asked when the handicap parking space would be completed on Jacobson Drive.

Stephen Holmes, Director of Infrastructure Capital Planning, advised that there are plans to work on Municipal Road 24 and the intersection of Municipal Road 55 to the north which would

include Jacobson Drive which is included on the Capital Program to be completed in the next few years.

Councillor Vagnini advised that Jacobson Drive was on the list three (3) years ago and was deferred each year with promises to be completed.

Stephen Holmes, Director of Infrastructure Capital Planning, advised they review the roads on an annual basis. He advised that he will look into Jacobson Drive and report back to the Councillor.

Line Painting on Centennial Drive

Councillor Landry-Altmann asked what happened to the lines that were painted on Centennial Drive last fall.

Stephen Holmes, Director of Infrastructure Capital Planning, advised that he will follow up with the project engineering team and report back to the councillor.
