This is being proposed out of concern for the general safety of the neighbourhood residents who have witnessed on a daily basis vehicles travelling at high rates of speeds coming off of Paris Street onto David Street. Also, making left hand turns (South) off of David Street onto Paris Street is extremely hazerdous crossing three lanes of traffic in such close proximity to the set of lights located John Street at Paris Street.
