
Now therefore Council of the City of Greater Sudbury hereby enacts as follows:

1. By-law 2017-2 being a By-law of the City of Greater Sudbury Respecting the Appointment of Officials of the City of Greater Sudbury, as amended, is hereby further amended by:

 - (b) repealing Schedule "B", Part 2 and enacting, in its place and stead, Schedule "B", Part 2 attached hereto as Schedule "B" and forming a part of this By-law; and
 - (b) repealing Schedule "C", Part 2 and enacting, in its place and stead, Schedule "C", Part 2 attached hereto as Schedule "C" and forming a part of this By-law.
2. This By-law shall come into full force and effect upon passage.
