I HAVE COMPLETED THE PETITION YOU ASKED ME TO CONDUCT REGARDING CHANGING DELWOOD COURT FROM A PLOW AND SALT ROUTE TO A PLOW AND SAND ROUTE. OUR PREVIOUS CONVERSATION VIA E-MAIL HAS BEEN ATTACHED.

THE VAST MAJORITY OF THE RESIDENTS SUPPORT THIS CHANGE. THE SURVEY WENT AS FOLLOWS:

THERE ARE 36 HOMES IN THIS AREA OF SUBDIVISION. ONE HAS BEEN VACANT FOR APPROXIMATELY 5 YEARS (4 JANMAR), ONE OWNER IS ELDERLY AND DOES NOT COMMUNICATE WITH PEOPLE AT THE DOOR (1081 DELWOOD); ONE HOME ON 1073 DELWOOD HAS OWNERS ON EXTENDED VACATION AND THUS THREE OF THE TOTAL OF 36 ARE EXCLUDED. / 33

A FEW OF THE OWNERS (3) NEITHER AGREE NOR DISAGREE FEELING THAT IT'S NOT AN ISSUE. WHICHEVER OUTCOME IS IRRELEVANT TO THEM.

ONLY 3 OWNERS DISAGREE WITH THE PLOW AND SAND PROPOSAL WHILE 27 APPLAUD THE CHANGE TO REDUCE THE IMPACT OF SALT ON OUR STREET AND LAKE.

I HOPE 27 IN AGREEMENT VERSUS 3 IN OPPOSITION IS SUFFICIENT FOR THE CITY TO MAKE THE CHANGE FOR THE FOLLOWING WINTER SEASON. I LOOK FORWARD TO THE PRESENTATION OF THIS TO COUNCIL IF THAT IS WHAT IS REQUIRED AND WOULD LIKE TO HEAR BACK WHEN YOU KNOW SO I CAN MAKE OUR STREET RESIDENTS AWARE THE CHANGE WILL BE UPCOMING. THANK YOU FOR YOUR ASSISTANCE. I WILL ALSO PROVIDE A COPY TO RANDY HALVERSON SO THE ROAD MAINTENANCE DEPARTMENT WILL HAVE A 'HEADS UP' ON THIS ISSUE.
