Report Summary

This report summarizes the renewal of a long standing Water Supply Service agreement between the City of Greater Sudbury and the Corporation of the Municipality of Markstay-Warren. The renewal agreement is a continuation of an existing agreement between the former Regional Municipality of Sudbury and the former Municipality of the Township of Hagar, as it was then, and now known as Markstay-Warren. The content of the renewed agreement has not been significantly altered from the original agreement, other than the cost/rate to supply said water to Markstay-Warren

Financial Implications

There are no financial implications as the water rate being charged to the Municipality of Markstay-Warren is in accordance with the current Water/Wastewater Rates By-law 2018-2 and the projected consumption is included in Council approved budgets.

By-law 2018-79

**A By-law of the City of Greater Sudbury to Authorize an Agreement
with the Corporation of the Municipality of Markstay-Warren**

Whereas by Agreement between the former Municipality of the Township of Hagar, now the Corporation of the Municipality of Markstay-Warren with the former Regional Municipality of Sudbury the former Region and subsequently the City of Greater Sudbury has been providing potable water since 1996;

And Whereas the Agreement for the provision of water has expired, and the Corporation of the Municipality of Markstay-Warren has requested that the City of Greater Sudbury now enter into a new agreement to continue to provide water;

And Whereas Council for the City of Greater Sudbury has determined that it is in order to do so;


Now therefore Council of the City of Greater Sudbury hereby enacts as follows:

1. The General Manager, Corporate Services is hereby authorized to negotiate and sign on, behalf of the City of Greater Sudbury, an agreement with the Corporation of the Municipality of Markstay-Warren for the provision of potable water, any subsequent amendments, renewals or extensions and any other related documents. The General Manager is further authorized to make all decisions and perform all functions required pursuant to the agreement in order to administer and implement the terms of the agreement.
2. This By-law comes into effect upon passage.
