

Good Afternoon. My name is Kathy Young, I live [REDACTED] and I have been a resident of Sudbury for [REDACTED] years. I've raised my [REDACTED] here, worked in [REDACTED] [REDACTED] have been an active member of the community pre and post retirement. On a number of levels, I am opposed to the building of an arena on The Kingsway, and am therefore opposed to the rezoning of the property.

First of all, as a retiree, I am very concerned about the incredibly high taxes we pay, and the effect on my taxes that expected infrastructure and capital costs being planned for the Kingsway location of a new arena will have. As compared to Victoria BC (as per last week's Globe), my current taxes are [REDACTED] more per year for a home of equal value. I and other seniors are experiencing the squeeze of proposed capital building projects coupled with the forecasted erosion in the Sudbury tax base.

But grumbling about taxes is not why I am writing today. For the past 42 years, I have been comparing Sudbury to Sault Ste. Marie where I was raised and regularly visit family. On so many levels, the Sault wins – for informed, smart, and timely decision making. And they make the smart decisions drawing on a tax base of just about half of what we have in Sudbury.

The following questions are rhetorical in nature, but have fun guessing....

- The Sault and Sudbury arenas were built in 1949 and 1951 respectively. In 2007 when both cities were investigating their aged arena properties, guess which city decided to build new immediately, and which city decided to renovate, only to revisit their decision 6 years later, and then remain mired in indecision for a further 4 years later, only to make the wrong decision?
- Guess which city decided to move the arena outside their city core, in contravention of their city master plan, and which city built their arena in their city core (as Ottawa might have wished)?
- Guess which city has been enjoying hockey and 1st rate concerts in plush seats and climate controlled comfort for 11 years?
- Guess which city, when they identified the need for a new library and art gallery years ago, accessed property on the river waterfront and build the most impressive structure, well used and visited by residents and tourists alike?
- Guess which city has diddled, renovated and fiddled with their library and art gallery with no resolve to date?

- Guess which city, when offered a golden opportunity to purchase prime, never to be offered again real estate on the shores of the most beautiful city water location available, diddled and fiddled?
- Guess what city's residents get to drive by the most spectacularly horrid eyesore on their way to work each day?
- Guess which city, when recognizing the need/desire of its citizens for healthy infrastructure, built non motorized trails (The Hub Trail – 22.5 km), bike lanes (dedicated bike lanes on many of the city's main arteries using provincial infrastructure monies), a huge community centre (The John Rhodes Community Centre) housing an NHL ice pad, 25 m, 8 lane swimming pool, full gym etc.)?
- Guess which city retained their post office building built in 1906 with its distinctive clock tower now housing their museum, and which city tore their beautiful heritage post office down?
- Guess which city has a lovely boardwalk along the waterfront, with patio bar/restaurants along the way?

We can't revisit the shortsightedness of our past city fathers. However, Greater Sudbury has made some smart, informed and timely decisions incorporated into its Official Plan, Downtown Master Plan and economic development plans. It's not too late to follow those them. Please don't throw all that good work out the window and amend the Official Plan as you are considering today. The time for making evidence-based decisions is now!

I will continue comparing the Sault to Sudbury, but please give me something to brag about to my sisters....

To forward to the Planning Committee of the City of Greater Sudbury,

I write to you today on behalf of young people like myself. Sudbury as a whole is having a hard time retaining young people, they leave after school and they don't come back. Those of us who stayed, or came back, did so because we saw Sudbury moving in a particular direction. We saw Sudbury moving in this direction from the various planning documents put out by the city; the official plan, the downtown master plan, and From the Ground Up, Sudbury's economic development plan. We chose to stay because we wanted to be part of the Sudbury those documents envisioned.

We chose to stay in a city that was focused on establishing healthy communities. A casino does not build healthy communities. Increasing urban sprawl does not build healthy communities. Spending an hour in your vehicle to exit the parking lot after an event does not build healthy communities. To imagine that families will go to eat dinner before an event in a casino, and to advocate this type of entertainment to our children and grandchildren is horrifying to me, and will not lead to a healthy future.

We chose to stay in a city that was making smart decisions, fact-based decisions. Section 19 of the Official plan asks the city to examine the financial impact of major developments. The financial impact of a casino is not good. It drains money from our community in the tens of millions annually, and gives back pennies on the dollar. The casino will harm local businesses, restaurants and retail, businesses whose owners have invested their lives in improving our community. The casino will harm charities. As charity bingos lose their patrons to OLG Casino, our charities will have to look elsewhere for funding or perish. Also, according to your own research taken from the Arena Large Project page of the City of Greater Sudbury website, the cost of a complete renovation of the current barn to update it completely would cost between \$44 and \$50 million dollars, less than half what this proposed arena will cost our city.

We chose to stay in a city that was moving towards a greener future. One of Sudbury's greatest accomplishments is the regreening effort. Part of moving to a greener future is


infilling our city instead of sprawling. What is the additional cost of upgrading the transit system, the sidewalks, and of adding bike lanes to the entire surrounding area to stay in line with our city's green initiatives?

We chose to stay in a city that was moving towards rejuvenating our downtown, not building a new downtown in an industrial park. An industrial park is not a place to send our young people for entertainment. An industrial park is not the first face we want tourists to see when coming to our city. This build also takes land away from industrial projects and makes the industrial park less attractive to future industrial ventures. Industrial operations do not want children walking down their sidewalks on their way to an event. They do not want the increased community traffic around their operations. They do not want to locate beside a casino. Industrial parks and community arenas do not mesh and forcing them together will lead to reduced economic development.

Make smarter choices Sudbury. Make the right decision. Don't make it easier for a casino to drain our economy by allowing it to be built next to our community arena. Don't put our community arena in an industrial park that will force people to sit in their cars for an hour to leave the parking lot. Build our community safer, healthier, smarter, wealthier, and more attractive. Don't push more people my age to leave for communities that better suit their values.

I would like to voice my opposition to the planned arena development on the Kingsway. To say the very least, this is a half baked plan that has a great number of serious concerns attached to it. I am late to the table here as it took me a long while to finally understand this convoluted plan that our council has put in motion.

Why did this city put so much energy into a strategic plan and then go on to ignore it? Smart cities and towns are designed around a vision of what communities should be, could look like. We see that when we visit other cities. The best of them have an elegance to their design; these towns and cities are visitor friendly, they offer creative spaces, green spaces, easy walking, retail spaces and service outlets. In other words they are built for people, but more importantly for a cross-section of people seeking various services, diversions, entertainment, gathering places, and shopping. And the best of these, the ones we enjoy returning to, are also aesthetically pleasing, even beautiful.

Sudbury as we can all admit is none of these, not yet, but it could be. What we need is a vision and we need to trust in that vision and make it happen. Instead the habit in this city is to do what seems easiest for the least cost. A good example of this is the Bell Park Amphitheatre. One of Sudbury's few design successes, the boardwalk is a fine example of smart and graceful design, in tune with the landscape but not dominating it. And it is well used: in conjunction with the skating path, the two sliding hills, the beaches, playground, the gazebos and the performance stage, it is practical and at the same time quite lovely. When it was announced that a new amphitheatre would be built, many Sudburians assumed that the finer design elements of the larger boardwalk area would carry into the design of the amphitheatre. The result was shocking and, to say the very least, disappointing. It is industrial in nature, a box, and has nothing at all to do with the surrounding landscape or the organic feel of the boardwalk that hugs the bay. Yes, I guess it was the cheapest way to go, but what a missed opportunity. When I walk by it on my regular walks, it is a constant reminder to me of the paucity of creative vision that has plagued this city for the many years I've lived here.

This half-hearted and mostly expedient approach to design in this city must stop. Future development must be in line with the larger plan that has already cost us money and many hours of consultation, cogitation and planning. What we appear to have is a complete lack of imagination on this council.

Moving forward on an arena complex and casino, on the outskirts of the city centre is unwise for a number of reasons that fly in the face of the city's master plan. These reasons have already been articulated by a number of concerned citizens and this in itself shows there is rampant opposition to this project and at the very least, doubt and confusion on the parts of many Sudburians. This alone is reason to take a breath and re-think this initiative. The following are only a few of my concerns over this proposed development:

- * the talk around the Kingsway complex suggests there may be an added conference/performing arts space attached to it. This would obviously conflict with the Synergy Centre. We don't need nor can we support two conference/performing art spaces. And we certainly can't risk investing in a downtown conference centre and then pit it against another similar centre around the casino.
- * the Kingsway location for the arena means an increase in transit routes to make it accessible and this would cost the city. The downtown is already a transit hub and this is a valuable attribute to any development.
- * much research suggests that casinos in a city of our size, don't offer much economic impact; in fact it has been noted that casinos actually drain money from the local economy.
- * Sudbury has some of the highest obesity, smoking and drinking rates in the province, if not the country. Do we need to add another element that will sabotage the well-being of many who have a predilection for gambling (yes, I know many can gamble responsibly but many can't).

My final conclusions are as follows:

***We simply do not need and should not have a casino in the city. The OLG slots at Sudbury Downs are adequate and accessible enough without being too easy.

***The arena should be located downtown. The small businesses downtown that have grown their businesses, deserve this opportunity. Arena goers will have better transit opportunities and a variety of retail and restaurants to choose from to enhance their arena experience, not to mention a movie theatre, library and art gallery all in close proximity.

***I am still of the view that the City Centre mall would be a good location for the art gallery and library. This is at present, an almost dead and unused space. The fact that many options are available in an indoor facility makes sense in our harsh winters, especially for seniors and families. We could re-constitute the failing mall model, into one that is a hub of culture, learning, food, film and retail. This would also use existing infrastructure which otherwise will simply erode from neglect and under use.

Please put the brakes on this development before it is too late. As a lifetime resident of this city I ask that you not grant the zoning request for this property, or at the very least, defer this decision until there is a more solid plan in place. There is a better more elegant way to design this city which can encompass all of these facilities in a smart, user-friendly and successful design.

We can't afford to get this wrong,

- The proposed use is not compatible with surrounding uses.
The subject lands are located within the Jack Nicholas industrial Park, and the impacts from industrial land uses might negatively impact on proposed gaming uses in a number of ways, including the presence of odour, noise and dust from industrial activities, along with truck traffic on interior roadways. Technical studies should be produced to demonstrate that there will be no negative impacts on the public from industrial uses in the industrial park.
- The proposed use is not an employment use.
A comprehensive review of employment land needs should first be undertaken to demonstrate the appropriateness of removing these lands from an employment area. The issue with a loss of employment lands is further exacerbated by related development applications for an events centre and parking facilities, neither of which are employment uses.
- The proposed use contemplates the unnecessary expansion of public infrastructure.
In particular, roads, transit, active transportation, and sewer and water infrastructure.
- The proposed use as a gaming facility is in conflict with the City's approach to establishing healthy communities, as per Section 16 of the Official Plan.
The gaming facility will not contribute to the overall health of community residents, and will instead lead to negative health effects. At the very least, health related impacts related to an anticipated increase in gambling addiction in the community should be studied by unbiased third party professionals prior to moving forward with establishing the use. Recommendations to minimize negative health impacts should be identified in Official Plan policy and implemented by the developer.
- Section 19 of the Official Plan requires the City to examine the financial impacts of all

major development projects to ensure financial sustainability.

The economic impacts of this new use in our City have not been assessed. An economic impact study is needed

to assess the impacts of this use on the fiscal health of the City, its residents and the business community.

Recommendations from this report to minimize negative impacts should be included in Official Plan policy.

- The proposal does not have regard to the development of a prosperous community.

Section 16.2. 3 of the Official Plan calls for adherence to the City's economic development plan (which does not contemplate the presence of a casino).

- The proposed use is not energy efficient.

The Official Plan Amendment does not include any policy direction that the building be constructed with energy efficiency and renewable energy production in mind, including geothermal energy and district energy as contemplated by Section 12.4.2 of the Official Plan.

- The proposed Official Plan amendment does not hold the land developer to high quality urban design, as called for in Section 14 of the Plan.

Policies should be developed to require high-quality urban designs be incorporated into the

buildings/structures and surrounding lands, including the use of winter cities design elements and techniques.

CASINO – LAND USE ISSUES

The applications do not conform to the City's Official Plan.

1

- The proposed location of the casino, adjacent to a proposed community facility (public arena) is inappropriate and not in keeping with the City's goals to create a healthy, sustainable community.

Gambling facilities and family-oriented public recreational uses are incompatible with one another.

- Establishing large surface parking lots in this area, needed to accommodate anticipated parking for the proposed use, have not been evaluated for their impacts

on the Ramsey Lake watershed.

In particular, there are concerns with additional salt loading.

The proposed uses as a casino and arena are not in accordance with the Official Plan. The proposed uses are not in accordance with good planning practices.


The Official Plan, Downtown Master Plan, and Economic Development Plan have stated long-standing goals of downtown development and should be followed.

Please accept this letter as notice of my opposition to both applications to rezone certain lands on the Kingsway for purposes of an Arena and Casino.

1) The Arena

The decision by council to remove the arena from the downtown is not in accordance with Sudbury's Official Plan.

Under 1.2 Vision - the Official Plan states:

Greater Sudbury's Downtown will be developed and sustained as the vibrant hub of a dynamic city by preserving its historical built form, promoting arts and culture, improving linkages to neighbourhoods and amenities, integrating natural features, developing residential uses, and creating unique urban spaces through innovative design.

By removing a core asset and attraction from the downtown, Council's decision ensures that the Downtown is reduced as a "vibrant hub".

Under 1.4 Context - the Official Plan states:

The heart of Greater Sudbury, its most urban place, is and will be the Downtown. With the changing role of downtowns, there is a continuing need for appropriate policies and programs to enhance the Downtown as a location of government, commerce, cultural and entertainment facilities. Residential development in and around the Downtown is needed to support new and expanded facilities and amenities.

By removing the arena from the downtown, Council's decision is doing the opposite of enhancing the entertainment facilities in the Downtown.

On a more personal note, several years ago my wife and I undertook a series of arena concerts through the Maritimes. As tourists coming to locations we had not been before, the only disappointing place for a concert goer was Moncton. After the concert, the only thing to do was sit in a large parking lot of a suburban arena site and wait for the lot to empty. Afterwards, a quick trip downtown showed a downtown that was closed down tight. Now, after putting up with a suburban arena for 35 years, Moncton is almost ready with the new downtown arena complex -

Maybe the City of Sudbury could learn something from Moncton's experience?

2) Casino

The fact that Gateway and OLG seem to be willing to locate a high-end casino and hotel beside the Sudbury landfill site shows they have no interest in using or promoting their facilities as a tourist attraction. The casino's only purpose will be to mine as much wealth as possible from the residents of Sudbury.

Under 1.3.2 Economic development, the Official Plan lists the five engines of growth as:

- **The best mining and supply services in the world;**
- **A city of the creative, curious and adventuresome (providing a quality of life to attract a diverse population);**
- **One of Ontario's top four destinations (capitalizing on our natural assets and history to attract residents and visitors);**
- **A leader in health innovation and biotechnology; and,**
- **A model for eco-industry and renewable energy**

Since the proponents of the Casino promote it as an enterprise for growth, to fall within the Official Plan it should act as a catalyst to make Sudbury one of Ontario's top four destinations. We are "The city of Lakes" not the "City of Dumps". The stigma of years of industrial devastation have finally been removed; let's not start again by being known as the city that promotes a tourist attraction by the dump. North Bay is placing their casino on their waterfront; Sudbury should be "capitalizing on our natural assets" to do better. A casino at the proposed location will not be an engine of growth; but it will be a source of constant embarrassment.

Under 1.3.3 Sustainable Development the Official Plan states:

Becoming a sustainable community involves adopting a long-term view in assessing options and making choices. It also means recognizing the value of healthy ecosystems, using resources efficiently, and enhancing a locally based economy.

One of the resources of the of the City of Sudbury is the wealth of its citizens. A casino as envisaged by OLG and the private operator does not create sustainable development. It only vacuums the wealth out of the community. It does nothing to enhance the locally based economy. Possibly there are options for locally operated casinos or places of entertainment that could keep wealth distribution within the community. A long-term view in assessing options is required. Jumping into a deal without assessing options is not appropriate under the Official Plan.

To who this concerns,

As a developer who has deep roots to Sudbury and recently investing heavily into Greater Sudbury - I have to take issue with the manner in which staff and council has handled the decision to locate the 'new event centre' on the outskirts of Sudbury. Contrary to all of the research, advise, time and money that has been spent.

Provincial Policy, the Northern Ontario Growth Act and Places to Grow Act are the succinct and clear guidelines that the Province has provided planners hired by their respective communities across our province to create sustainable growth and development.

As it related to Provincial Policy - the City of Greater Sudbury (CGS) for the purposes for the 'event centre' has completely disregarded its own Master Plan, Downtown Plan, Downtown CIP and Brownfield CIP programs, contrary to the Provincial Policies which Municipalities are required to follow and to adopt. Pick a spot within any of the sections of this directive which has formed CGS Master Plan, Downtown and Town Centre Plans and you will find contradictions which will be challenged at several levels - whether OMB, MOE, MNR and others. <http://www.mah.gov.on.ca/Page10679.aspx>

The KWED is as much of an entertainment district as the city dump is an oasis which we go to enjoy the sun in the summer. Has a hotel operator been identified in the proposal? No hotel operator work their reputation would want to have to deal with any prospective quality issues that would effect the pleasant enjoyment of the facility for their guests. The suggestion to place a Hotel, Casino, Arena and other undefined pleasure uses located +/- 1.0km from an active landfill which is designated to handle Brownfield soil is reckless - not to mention nuisance wildlife like bears.

What is the transit plan to accommodate the 1000's of people who may not have the means for their own vehicle or to get to this site en masse or in off hours? Where is the economic viability statement? Do you have a long-term agreement with SWSE?

One may want to question Councillor Kirwan who provides 'paid, education based endorsements' through his Valley East Today Facebook site and his emphatic enthusiasm for KWED. Has he been paid to endorse the KWED project under the guise of this Facebook site?

Promoted, and leading up to the vote, the public was lead to believe that an additional ice pad, soccer field house, watersports park, motorsports park and other 'attractions' were to be included. How do they fit into the site, what does the traffic study state about adding these items and how does that effect the infrastructure which doesn't currently exist. Where are they?

Based on action of staff and council that have undermined their own plans and the direction of the Province - CGS has lost both credibility and integrity among it contemporaries in the Province and Country.

Investors into Sudbury need to know that there is a stable, bankable, reliable staff and council that can't be counted on to do the very things that they have stated in Official Plans, media and public forums - or else, you will be lost.

But, it is worthy of note that **virtually all of the presenters were opposed to the development location**, excepting Mr. Zulich, the Gateway representative and perhaps one or two others. I guess the "silent majority" are truly silent and choose to not advocate their position.? If there is a great citizen support for the Kingsway development they did not show it; where is it? Why are they not speaking, where **everyone was given this opportunity** at our perfect venue, the Council Chamber of the City of Greater Sudbury?

Thank you for your consideration. We look forward to your support for the **Heart of Sudbury... Downtown.**

Madam Chair and Members of the Planning Committee, City of Greater Sudbury:

My name is Arthur Peach and I appear before you in common voice with my business and professional partner, Oryst Sawchuk. We are an architectural-planning consulting practice that has been, and still is, active in Sudbury and throughout Ontario since 1957...over 60 years. I think we have some sense of the ebb and flow of development over the past few years.

You, as members of the Planning Committee of council, are governed in your deliberations and decisions, among other Statutes, by the Official Plan. You and your staff have a stewardship obligation to assure the implementation of the Official Plan on behalf of the citizens and institutions of Sudbury. (we all know that; nothing new here)

What is unprecedented is the contemplation of spending well over 100 million dollars for an arena/event centre, not to mention tens of millions for the supporting infrastructure, in a wildly inappropriate location.

Oryst and I express our great concern that the applications before you, in almost every category of reference to the Official Plan, can not be justified and must be rejected in favour of a rational planning, economically sustainable and realistic approach to the development of our new arena/event centre/performing Arts Facility...in the downtown.

We respectfully and urgently suggest that it is your civic duty as members of this committee to reference the Official Plan, to advocate

passionately and to demonstrate rationally how and why a civic project of such colossal scope should be built in the Downtown (and I quote the Official Plan here)...”the heart of Greater Sudbury, the most urban place” “to enhance the Downtown as a location of government, commerce, culture and entertainment facilities.” (close quote),....not remotely on the periphery of the built centre of our community, not on land designated as Heavy Industrial by the Official Plan, not adjacent and connected to a casino of all things, not neighbouring the Municipal landfill site...(more plainly put; the city dump).

I repeat this pertinent excerpt from the Official Plan that you as Stewards of the plan should keep in mind, and act on.

“Section 1.4 of our Official Plan states,
under Context:

“The heart of Greater Sudbury, its most urban place, is and will be the *Downtown*. With the changing role of downtowns, there is a continuing need for appropriate policies and programs to enhance the *Downtown* as a location of government, commerce, cultural and entertainment facilities.”

We have witnessed many changes to the City and its Downtown, much of which has been detrimental to its role as the City’s central place. What was once a walkable, people place has been incrementally hollowed out to serve private commercial interests, and without much thought for the peoples’ interests.

After Six decades of municipal planning with it’s fine rhetoric we favour the Downtown as the heart and core area of the City. Planning committees and councils throughout these years have failed their responsibilities to the Official Plan.

Today, the proposed public works expenditure of more than \$100 million represents an opportunity to invest in implementing the Downtown public policy of the Official Plan. Leveraging this investment together with taking stock of our Downtown resources and using them in innovative ways to create a truly inspired, imaginative cluster, demonstrative of all that Sudbury can be going into the next 150 years. The Downtown can become what we all aspire to, a diverse, resilient, more economically viable neighbourhood.

The opportunity is NOW, ...you are the stewards, responsible for implementation of the Official Plan... show the leadership required to move us into the future and make us proud of our Downtown and City. Be pro-active on this matter; make a statement. After six decades of neglect let's do the right thing now in accordance with the mandate of the Official Plan.

Can you envision (quoting again from the Official Plan..."a Sudbury, compact and walkable, the Downtown possessing a distinct built form that sets it apart from other urban areas, offering unique opportunities to protect, develop and sustain its role as the vibrant hub of a dynamic city.

This is your challenge: we have an Official Plan vision which must be interpreted in the context of the whole community, not just an isolated property. Your support of the total and unanimous rejection of these requested amendments to the zoning and Official Plan statutes will be a worthy legacy of this committee and council. Our community says live up to your leadership responsibilities. Thank you.

To Whom It May Concern:

After observing the proceedings at the city Planning Committee meeting on January 22, 2018 I feel compelled to make my concerns known in writing regarding the two applications.

The following concerns apply to both applications.

I live in [REDACTED] In 2012 I attended several Planning Committee meetings regarding a rezoning application from Dalron Construction to rezone the all the property on the hill [REDACTED] in the vicinity of the Sudbury Curling Club to allow Dalron to build a large subdivision on the property. To make a long story short the application was denied by the Planning Committee because of the heavy traffic situation along the Minnow Lake corridor - Howey Drive, Bellevue, Bancroft Drive and Second Avenue. This busy corridor connects Paris Street with the east end of the Kingsway. It was determined that Howey Drive and the corridor in general are at capacity and no further development can occur in this area until these two-lane roadways are widened to at least 3 lanes. As was well documented in the Dalron matter, this corridor has become a main alternative to the Kingsway – a much lamented bottleneck for traffic flow in our city. This situation remains unchanged since the 2012 Dalron decision and there appears to be no imminent move by the City to remedy this matter.

My concern is that locating the Events Centre (and the Casino) at the east end of the Kingsway across from Levesque street will only add to the already unacceptable volume of heavy traffic along the Minnow Lake corridor. As well with this development the list of affected roadways will expand to include all of Bancroft Drive and the Levesque Street and Moonlight Avenue connectors to the Kingsway and the Events Centre as motorists travelling to and exiting from the Events Centre will follow a well established routine of choosing the Minnow Lake corridor to avoid the Kingsway bottleneck.

The Minnow Lake corridor is a heavily populated residential area. With most of the affected roadways being 2 lanes and having bike lanes on both sides, vehicles making a left turn to exit the corridor hold up traffic. This results in many motorists automatically using the bike lanes to get around the left turning vehicle giving rise to many safety concerns for cyclists and pedestrians alike. This situation will only get worse as motorists use the corridor as a throughway to get from one end of the city to another focused on arriving on time for events and heading home or to other activities afterwards.

My second concern is that the location of the Events Centre (and the Casino) is against the Official Plan Section 4.1.c. “promote the development of the Downtown as an employment and business centre for the City”. This plan was created and is maintained in good faith at considerable expense by the tax payer in order to guide the city's planning efforts. The decision by council to proceed with this project which will purposefully draw major development and employment opportunities away from the downtown shows a flagrant disrespect and disregard for the will of the citizens as stated in the Official Plan.

I am also extremely concerned about the environmental impact that developments will have on Lake

Ramsey a main source of our drinking water. Already I am tasting salt in the tap water due to questionable water management practices, poor planning and development policies regarding the watershed for the lake. Studies show that the high volumes of salt and other contaminants in the run off from the large parking areas associated with the development will ultimately be deposited into Lake Ramsey via the ground water which studies show flows towards the lake. By choosing this location Council will further contribute to the demise of our lovely lake which is already in a fragile state and jeopardize the health of our community.

My final concern is in regard to the rezoning application for the casino development. Policy 1.1.1 of the Provincial Policy Statement pertains to development which contributes to “sustaining healthy, livable and safe communities.” Building a casino next to an Events centre which will be a venue for family orientated activities and in close proximity to residential neighbourhoods does not support our efforts to be a healthy and safe community. Gambling and it's well documented negative outcomes of addiction, crime and poor life choices and practices are certainly not conducive to encouraging our children and youth to adopt a healthy and safe lifestyle.

For the sake of our well being as a community both rezoning applications and the Casino development itself should be rejected by council and the Events Centre incorporated into the development of our Downtown according to the provisions of our Official Plan.

Thank you for your time in reading my reasoning as to why council and staff should not rezone the Kingsway property for the event centre. It is not for the reason that I am an advocate in keeping/ or building the new centre downtown. Through my research visiting other cities speaking with businesses and councilors in various cities, I have learned various ways they took bad situations and areas of their downtown and made them a place of pride for all visitors along with increased tax dollars from the new developments surrounding downtown event centres. But this is not the reason for my letter not to rezone the Event Centre location.

The reasons I wish to share with you regarding not rezoning the event centre land is that of a business positioning itself for the best for its city. You (Greater Sudbury) are embarking on one of the largest projects in the city's history maybe even bigger than the Borgia district. With that project, just like this one it was not and should not be rushed. I say this not to be disrespectful to all that are involved in this project however with the construction of the of the walkway on Tom Davis Square, where staff hired an outside consultant to run this project and with him not knowing the area he set the RFP with the wrong brick size and dimensions to which a local company told staff and that was changed which then came with added costs to the project because this 3rd party was not knowledgeable of the area. The same could be said here as council hurried the process by "saving money" using the referral of Mr Zullich and Gateway, by using their referred architect for the design of the casino and event centre. With this referred person/ company not knowing the city and climates unlike many local architect companies along with companies that build event centres may have noticed and designed differently with proper pedestrian traffic flow in the venue. As Councilor McIntosh posing the question "that it is a great design but we being in the north and have cold climates what happens to "Festival Square" with a cold northerly wind?" To which the response was that we will plant trees and shrubs.... but they lose leaves in the winter. With the design given you (council and staff) should ask the question, what other centre, with a hockey team as the main tenant have the main entrance behind a net and next to the loading dock? Most to all venues have their main entrance at or about the centre ice, this may be chalked up to inexperience and as a city you should be placing an RFP for numerous designs that could work with the gateway casino design. This is our \$100 million worth of tax dollars your investing should it not be done right and not rushed?

Another reason not to rezone for the event centre is that we/you/the event centre is the primary tenant to this project. Mr Zullich and Gateway do not have any signed agreements just a promissory note to build. A promissory note is just like that hand shake in Jerry Maguire it meant nothing unlike the signed contract, meaning you have the preverbal puck on your stick. Once you rezone and take the land you cannot back out, would it not be better to know the terms and agreements that the casino will have with Mr Zullich first? The casino states it will have 3 restaurants and a convention centre in it (ie: French, Italian and Asian restaurants) will that mean they will have a no competition clause so that no other restaurants with Italian cuisine will be allowed on all that land. WalMart has a clause much the same with fresh foods that no other competitor could sell fresh foods on the mall property something normal with private companies leasing with private companies to keep their competitive edge however this is why Dollarama in the old future shop is the only Dollarama not selling bread (fresh foods) in its store. Is this something the city wants to work with, if we (Greater Sudbury) are trying to show

businesses looking at investing in Sudbury to find out that we are open for business however we invested \$100 million on an event centre for the people of Greater Sudbury but we also agreed with a no competition clause so you might not be able to invest in our city or bring more jobs to Greater Sudbury, does that go against the moral values of the city?

A person that runs Northern Lights Festival Boreal stated that casino Rama held the rights to some musical groups that NLFB was trying to bring to Sudbury for our entertainment and festival but could not because it would violate the geographical terms of the contract with Rama. What type of terms will this casino have against our event centre? If a band or comedy act or any other event plays at Gateway Casino's Convention Centre (which is direct competition to our event centre or for that matter the Synergy Centre or Place du Arts Centre), will those acts not be allowed to play at our events centre or any other location in Greater Sudbury because of terms/ agreement Zullich Enterprises and Gateway have agreed too, how will this affect our other local festivals and events?

The city needs an experienced negotiator to work terms with Mr Zullich and the wolves before rezoning takes place so this way the city still holds the power or the puck and get the best deal for the city which is what a third party facility manager (SMG, Eventko, Global Spectrum...) will do along with making sure the city will be profitable. The City is already losing 300k per year on the current arena with the terms negotiated by city staff (giving all concessions and arena advertising revenue to the wolves), it will be much more if not negotiated correctly. Holding the zoning for the event centre keep the negotiating powers in the hands of the city for the terms of what the casino can and cannot do as well as setting the terms for the Sudbury Wolves is good business. Having all terms and agreements in hand prior to a shovel hitting the ground ensures that the entire city of Greater Sudbury is getting the best deal possible for the next 30-40 years with this event centre. This is the Legacy staff and council will be handing to the council and staff of the future should we not make sure that it is left in the best direction possible? Meaning no rezoning until the terms with Gateway and Zullich Enterprises are acceptable for the city, something again an experience negotiator and venue management team would be able to do for the city. Going in a different order may also limit your options of 3rd party companies bidding to run the venue which then could put you in the same place as you (the city) are now, running the arena yourself with a bad contract that makes no profit for the city and it will continue to run on a deficit only it will be more since we now have to cover the debt costs of building a new centre.

I contacted and assisted staff with ideas and knowledge regarding Mr Zullich amending the Sudbury arena contract and taking 100% control where he decided not to amend the contract. Was it because he was not going to profit enough on the use of a city owned building or did he notice the terms would not be as favorable taking over the entire venue after I spoke with staff and they added additional terms. Side note: I also mentioned to staff that I was willing to run the arena for the years until the new centre is built, I haven't heard back from them since Mr Zullich reneged on his amendment.

In Conclusion I would like to repeat that the city should not rezone the land for the entertainment centre until all above mentioned has been taken care of, this is the councils and staff's legacy and a project that will be used and become an iconic building for our city for years to come do you as council and staff not want to make sure it this venue is done right. I also believe you should rezone for the

Casino so that Gateway and Zullich Enterprise are able to work on the terms of their agreements without zoning road blocks and the city/ 3rd party facility management group can see if these terms will be suitable for the city and its \$100 million investment.

As you know by now, last week agreement in principal was reached to move the main Ottawa arena to downtown Ottawa. As someone who has attended concerts both at the Kanata complex and Lebreton Flats (summer obviously), I can vouch as a tourist this makes going to a major event in Ottawa much more enjoyable. Of course, the Kingsway proponents will argue that you can't compare Ottawa to Sudbury.

A much better comparison would be Moncton. Moncton's new downtown event centre will be coming online this year. From what I've seen there has been none of the controversy that has surrounded the Sudbury decision to move our event centre out of the downtown. The current Moncton Coliseum is 6.5 kilometres from the Moncton downtown core; the proposed Sudbury event centre will be 7 km from the downtown core. Please check out:

I read in a former paper of cities who have casinos & wish they did not.


Some feel it's going to be a great influx of money for our city, but as was stated, it is bad for business places & for people's lives.




