Councillor Lapierre asked for an update on the move of the Hanmer Food Bank.

Tyler Campbell, Director of Social Services, stated that the Hanmer Food Bank moved into the storage garage at the Lion's Den in June. They moved the Lion's medical equipment stored in the garage into two (2) "Cubeit" storage containers. They were in search of a more cost effective option for storing the medical equipment. He has spoken to the Manager of Real Estate about the possibility of using the two (2) garage bays at the vacant depot on Desmarais Road that the Parks department formally had and still has use of. The site has been deemed surplus and has very little interest, therefore they would have plenty of time to move the equipment if necessary. This would be a good solution for all parties involved.
