FA2017-24 Vagnini/Kirwan: WHEREAS since the Board of Directors of the Maison McCulloch Hospice submitted their capital funding request to the City of Greater Sudbury in the sum of \$450,000 over 3 years to help cover the capital cost expenditures to undertake the expansion of its 10-bed community residential hospice in Sudbury in April of 2017, they have learned that their estimated capital costs for site development have increased by \$300,000;

AND WHEREAS the business case prepared by City staff for the inclusion in the 2018 budget addresses the initial request for the sum of \$450,000;

THEREFORE BE IT RESOLVED that the business case for the capital funding request by the Board of Directors of Maison McCulloch Hospice and the Sudbury Hospice Foundation be amended to reflect the most recent request in the sum of \$750,000.
