By-law 2017-216

A By-law of the City of Greater Sudbury to Authorize the Neighbourhood Playground Association Grants for the Year 2017

Whereas pursuant to Section 107 of the *Municipal Act 2001*, .S.O. 2001 c. 25, Council may pass by-laws for grants to certain bodies for purposes in the interest of the municipality;

And Whereas Council of the City of Greater Sudbury allocated certain funds in the year 2017 for the making of grants to approved Neighborhood Playground Associations for expenditure on equipment, for use as seed funding for special projects, the holding of community events or to cover operational costs;

And Whereas Council of the City of Greater Sudbury wishes to authorize the making of grants to approved neighborhood associations for approved purposes;

Now therefore the Council of the City of Greater Sudbury hereby enacts as follows:

- 1. Council of the City of Greater Sudbury hereby authorizes the payment by way of grant of the amount identified in Column C, to the non-profit organizations identified on the corresponding line in Column A, for the purpose set out on the corresponding line in Column B, all as set out in the chart on Schedule "A" attached to and forming part of this By-law. These are one time grants for the year 2017 only.
- 2. The Treasurer is authorized, upon the written request of the General Manager of Community Development, to advance up to the amount specified in Column C of Schedule "A" to the group identified in Column A of Schedule "A" for use by the grantee for the purpose described in Column B.
- 3. The General Manager of Community Development is authorized to execute such agreements and other documentation as may be necessary to support these grants.
- **4.** This By-law shall come into force and take effect upon final passage.
