- (d) repealing Schedule "C", Part 1 and enacting, in its place and stead, Schedule "C", Part 1 attached hereto as Schedule "D" and forming a part of this By-law;
and
- (e) repealing Schedule "C", Part 2 and enacting, in its place and stead, Schedule "C", Part 2 attached hereto as Schedule "E" and forming a part of this By-law;

2. This By-law shall come into full force and effect upon passage.
