## **PETITION**

## We, the

residents of Ward 4, residing on Montee Rouleau and St Laurent, in the Community of Rayside-Balfour, residents of the City of Greater Sudbury, are requesting a 4-way stop sign be installed at the corner of Montee Rouleau and St-Laurent.

Whereas a number of Valley East residents whose place of employment is located in the City of Sudbury now use the intersection of Montee Rouleau & St Laurent St for access to and from Blezard Valley, Val Caron, Val Therese and Hanmer because of the daily congestion on RR # 80.

Whereas any type of traffic disruption occurs on RR # 80 (whether accident or construction) from the Lasalle Blvd intersection and Hanmer the 4-lane traffic normally travelling on RR # 80 reroutes to the 2-lane Montee Rouleau which prevents traffic from St Laurent to access Montee Rouleau which causes the traffic on St Laurent to back up in some instances all the way to the lights at the intersection of Valleyview Rd and RR # 80.

Whereas the vehicles, heavy trucks and transports travelling on Montee Rouleau while approaching the intersection of Montee Rouleau and St Laurent travel in excess of the posted speed of 50 Km and there is a great concern for the children in the area waiting or exiting from the school buses or walking on these roads. Police enforcement is not the solution for this particular intersection as they are seen from a distance and the result is traffic slows down.

State the specific request for action you wish Council to undertake. For the safety of our children and ourselves we are requesting council to approve a 4-way stop sign at the corner of Montee Rouleau and St-Laurent as soon as possible before someone has an accident and incur death or serious injuries. There are at least 2 near misses per week that I have witnessed.
