### **BACKGROUND**

The subject road measures 14.37 metres x 53.91 metres (47.17 feet x 176.88 feet) in size and is zoned "R2-2", Low Density Residential Two Zone and "R1-5", Low Density Residential One Zone. The location of the subject road is identified on the attached Schedule 'A', and an aerial photograph of the subject road is identified on the attached Schedule 'B'.

In 1974, the former City of Sudbury became the registered owner of the subject road through the subdivision process.

# **REQUEST**

The Real Estate Section has received a request from Vale Canada Limited (Vale) (with the support of Glencore) to close Garson Lake Road from Cedar Street to Sunderland Road in order to allow Vale to install locked gates near the southern limit of Garson Lake Road, and at the intersection of Garson Lake Road and Sunderland Road.

Garson Lake Road north of the subject property is owned by Vale and Glencore. Vale and Glencore have expressed concerns regarding repetitive illegal dumping along Garson Lake Road between Cedar Street and Sunderland Road. Vale has proposed the installation of gates to prevent vehicular access and prevent further illegal dumping.


All of the lands abutting Garson Lake Road, north of the subject property, between Cedar Street and

Sunderland Road are owned by Vale or Glencore.

Although historically the City has maintained the portion of Garson Lake Road between Cedar Street and Sunderland Road, the City claims no interest in the section of road beyond the subject lands. The City does not hold legal title to this section of the road.

The proposal to close the road was circulated to all City departments and no objections were received.

It is recommended that a by-law be presented to close the section of Garson Lake Road (a.k.a Lake Road) on Plan M-1000, owned by the City.
